Industrial zone's concern over **Budget**

The Mauritius Export **Processing Zone** Association (MEPZA) said its members were not satisfied with measures announced for this sector in the June budget presented by Finance minister Paul Bérenger

MEPZA's director, Danielle Wong, said that the free zone industries were having difficult times because of tough competition from Asian countries and high costs of production, among other problem.

"We feel that the sector has been completely neglected by the government", she said.

Mrs Wong emphasized that people tend to minimize the problems in this sector while 5,000 jobs have been lost.

She said that the departure of major Hong Kong enterprises from Mauritius represents a warning to the industry.

"When these enterprises are leaving Mauritius, why US and European buyers would come to Mauritius?", she asked.

Mrs Wong dismissed arguments by the authorities that the free zone sector was not competitive enough.


"It's easy to say so. They ask proof of competitiveness from the free zone industries only. What about the other sectors the banks, the insurance companies, the port and the airport", the MEPZA's director asked.

According to her, there are high risks of social explosion in the island if appropriate measures are not taken.

«The free zone sector employs more than 80,000 people. Several thousands have been sacked; others would go in the coming months. This is a serious social problem», she

Misprints and mistakes

A reader, considering the extent of misprints that occur in the paper, told us "please do be a bit more careful with your proof-reading.' Well, we do our best with this proof reading exercise before going to the printers, but unfortunately we still find that the wrong versions are frequnetly printed.

On the other hand, as some workers find that the fault lies in their tools andnot in themselves, we must say that one of the upgraded versions of the publishing software we are using is the worst that the company has put on the market. Even the printers agree to say so. This software causes a lot of confusion in texts saving.

What can we say more about this proof-reading exercise except to repeat what the Guiness Book of Records (1989 ed) says under the heading newspapers - Most misprints: "The record for most misprints in the The Times was set on 22 Aug 1978 when on Page 19 there were 97 in 5 1/2 single column inches. The passage concerned 'Pop' (Paul) V1." Well, what The Times can do, we seem to do as much, if not better!

Mistakes and errors

When it comes to errros and mistakes, we may make mention of the famous error which in turn has made Mauritius famous in the world of philately. The two words Post Office on the GPO building (see picture above) were mistakenly engraved on the plate to print first stamps issued by Mauritius in 1847. This no legend, error there was. (See reproductions below).

But it is believed that the legend is about French watchmaker Joseph Osmond Bernard (an ancestor of renowned heart surgeon professor Barnard) who was given the job to engrave the plate with the words 'Post Paid'. The legend is that he forgot his brief.

On the way back to check with the official who entrusted the job to him, he saw the two words 'Post Office' on the GPO building which he took to be the very ones he was given. The rest is philatelic history. The Post Office stamp is one of the rarest and the most expensive in the world.

Nelson Mandela Centre?

The Government Post Office has moved from this historic building which will now be named after Nelson Mandela, we are told. Why Nelson Mandela? It has been reported that the man snubbed Mauritius and ignored all personal invitations from the government for a State visit to the island while he was president of South Africa. It was only when he was to step down as President of his country that he attended an African summit in the country. Apparently, he never forgave Mauritius, considered as a sanction-buster during the Apartheid era. Already an prominent square by the Theatre of Port Louis bears his name!

The GPO building, birthplace of Commonwealth stamps (Mauritius being the first British colony to issue postage stamps in 1847), should become a Mecca for philatelists from all over the world and should bear a name more appropriate to the World of Stamps. Many people who have shown great intrest in the philatelic history of

Noise is a major cause for complaint

According to the Central Statistical Office (CSO), on average 385 complaints were received yearly between 1994 and 1999. In its latest environment bulletin published in early April, the main complaint was noise, which accounted for over 25 per cent of all complaints received during that period.

"A marked increase was observed in 2000 when the number of complaints received was more than five times that of 1994. This was mainly due to the increasing awareness of the public to environmental issues and to the creation of the flying squad and the hotline to attend to complaints", the CSO said.

Commenting on the economic and social activities on the island, the Office said, from 1990 to 2000, the Gross Domestic Product (GDP), had in nominal terms increased by about threefold from Rs 39,629 million to Rs 118,478 million.

"The share of agriculture in GDP dropped from 12.8 per cent in 1990 to 6.7 per cent in 2000, manufacturing also decreased marginally from 24.2 per cent to 23.8 per cent while that of financial and business services increased from 14.4 percent to 18.1 percent", it emphasised.

During the same period, the population increased by 11.6 per cent from 1,056,800 in 1990 to 1,179,100 in 2000, and the population density from 518 to 578 square

Between 1986 and 1995, the proportion of agricultural land dropped from 48.2 percent to 46.4 per cent, and forestry land, from 35.1 per cent to 30.6 percent whilst there was an increase in built-up areas from 13.4 percent to 19.5 per

The CSO said, that in the year 2000, the total forest areas was 56,629 hectares, of which 22,089 hectares were owned by the State and 34,540 hectares privately-owned.

Around 90 per cent of the island's agricultural land was for sugarcane plantation with the remainder being occupied by foodcrops, tea and tobacco.

The CSO said the consumption of fertilisers for the year 2000 amounted to 67,044 tonnes, showing a decrease of 1,503 tonnes (-2.2 per cent) over 1990.

It added, while being an essential ingredient for the economic development and for the wellbeing of the population, energy-related activities were also a source of major concern for the environment.

"They are by far the most important contributors of air pollutants through the emission of carbon dioxide and other greenhouse gases", the CSO said. Statistics show that between 1990 and 2000, the total primary energy requirement of the country rose by 58.7 per cent, from 734 ktoe (a thousand tonnes of oil equivalent) to 1,165 ktoe, equivalent to an annual growth rate of 4.7 per cent.

Fuel oil, which represented 59 per cent of total energy used in 1990, dropped to 39 per cent in 2000. Consequently, a considerable rise in the use of coal and bagasse is noted in 2000 due to the production of electricity by independent power producers of the sugar industry.

In 2000, final energy consumption amounted to some 1,049 ktoe. The largest consumers were the transport and manufacturing sectors which accounted for 37 per cent and 34 per cent of the total consumption respectively. Between 1990 and 2000, final energy consumption increased on average by 4.2 per cent per annum.

The CSO says, "industrialisation, continuous economic growth and higher standard of living have led to a rapid increase in transport services over the recent years. A number of environmental problems are associated with transport, especially emission of carbon dioxide and other pollutants such as nitrogen oxide, volatile organic compounds, sulphur dioxide and particulates."

Concerning the transport sector, it indicated that the fleet of motor vehicles had nearly doubled between 1990 and 2000 from 123,545 to 244,018.

"This expansion has been accompanied by a similar growth in energy consumption and carbon dioxide emission in the transport sector", it added.

The CSO said between 1990 and 2000, total carbon dioxide emissions from fossil fuel more than doubled from 957 Gg to 2580 Gg.

Emissions from electricity production industries, manufacturing industries, transport and residential sectors increased by 244 per cent, 93 per cent, 138 per cent and 142 per cent respectively.

Giving statistics on water, it said on average, Mauritius receives 3,900 million cubic metres of rainfall every year. Some 30 per cent of this water is lost through evapotranspiration while surface runoff and ground water recharge account for 60 per cent and 10 per cent respectively.

"The water demand was estimated at 982 Mm3 of which, 468 Mm3 (48 percent) were used for irrigation, 305 Mm3 (31 percent) for hydropower and 209 Mm3 (21 percent) for domestic and industrial purposes."

Around 85 per cent of the total water demand was met by surface water and the remaining 15 percent, by ground water.

Farmers and fishermen, victims of cyclone Dina still in distress four months later

The Confédération des planteurs de Maurice held a meeting at the Octave Wiehé auditorium recently to discuss measures to be taken following cyclone Dina and its effects on the island's agriculture.

Members of the Confederation said their plantations had been destroyed during the cyclone and they needed some compensation from the government to be able to start cultivating their land again.

Member Kreepallou Sunghoon declared that farmers had lost their investment during the cyclone and were not able to recuperate any vegetables. "They have no money and no food; they already owe money to the Development Bank of Mauritius, they no longer have any fund to invest on their plantations", he said.

On his part, the chairman of the Federation of fishermen's Associations, Mr Antonio Lamarque, criticised the government which, according to him, had not helped fishermen in the aftermath of the cyclone.

"Fishermen have not been able to fish for days and our boats and other equipment have been destroyed", he said.

he has been asking for financial help from the government to enable fishermen to repair their boats and buy some equipment.

Sex discrimination Bill announced

The Ministry for Women's Right, Family Welfare and Child Development has announced the introduction of a Sex Discrimination Bill to give effect to certain provisions of the Convention on the Elimination of All Forms of Discrimination Against Women.

According to an official of the ministry, the bill is meant for debates among the population before its introduction in parliament in a few weeks time.

"The bill is also destined to provide for the elimination of discrimination against any person on the ground of sex, marital status, pregnancy (including potential pregnancy) or family responsibilities in employment, professions, education, provision of goods, services and facilities, accommodation, disposal of property, sport, associations and clubs", he said.

A Sex Discrimination Commission will receive complaints regarding alleged infringements of the Act, and will have the power to make enquiries and determinations and promote recognition and acceptance within the community of the principle of the equality of men and women.

He said the Bill would also eliminate all forms of sexual harassment in the workplace, educational institutions and other areas of public activity.

"No employer, and no officer of an employer, shall sexually harass an employee or a person seeking employment from the employer. No principal shall sexually harass a contract worker. No officer or employee of an employment agency shall sexually harass another person in the course of providing, or offering to provide, any of the agency's services to that other person", he said.

He emphasised that the Sex Discrimination Commission would, receive complaints relating to alleged infringements of this Act, endeavour by conciliation to effect a settlement of the matter to which an alleged infringement relates, cause such enquires to be made into a complaint in such manner as it thinks fit, make such recommendations as it deems appropriate to any appropriate authority; referring any complaints the Director of Public Prosecutions if it thinks fit to do so.

As regards to the offences, the official said, "any person who contravenes this Act shall commit an offence and shall, on conviction, be liable to imprisonment for a term not exceeding 12 months and to a fine not exceeding Rs 10,000."

Freeport sets its priorities

The Mauritius Freeport has set its priorities and its objectives for the years 2002/2005. According to a strategic plan presented in March, the objective is to reach a new level of development that would insure its growth and its competitiveness.

One official said seven important priorities had been identified: the promotion of the freeport, the setting up of a regulatory body, the use of land near the airport, the development of partnership with the main actors of the freeport, the development of competences, the diversification of products and the orientation of the organisation towards clients'

He said the Mauritius Freeport Authority considers that an efficient and aggressive marketing of the freeport should be launched in order to promote the sector as a supply and a competitive transhipment centre in the region.

It also aims at encouraging international companies to use the logistics support set up in Mauritius.

The MFA should work towards making the centre a true regional centre for distribution and marketing for local and foreign companies. It should also see to it that maritime companies use Mauritius as aregional transhipment centre and that the services and facilities offered by the freeport be known around the world", he said.

Mauritius ranks eighth in Africa on the FDI front

According to the World Investment Report for the year 2000, Mauritius was ranked eighth among African countries as far as Foreign Direct Investment was concerned.

The report said Mauritius obtained 275 million US\$ as FDI in 2000, against only 50 million USD a year earlier.

"This rise in the FDI was due to the sale of 40 per cent shares of Mauritius Telecom to France Telecom in 2000", the report said.

The report added that Angola ranked first with 1.75 billion US\$, followed by Egypt (1.25 billion US\$). Nigeria, South Africa, Tunisia, Sudan, Ivory-Coast, Mauritius, Uganda and Lesotho fol-

International petition for Le Morne to be declared a national heritage

The 'Collectif pour la préservation du Morne', an international petition to ask for the classification of Le Morne as a national patrimony was launched in March.

"This site in memory of slaves is a natural sanctuary. We are against any tourist project on it", members of the Collectif said. Historians Vijaya Teelock, Yves Pitchen, Gabriel Sameon and others said, "there exist around the world several memory sites

and Le Morne in Mauritius is one of them."

Construction set to spoil natural beauty of Mauritius

From the rear balcony of an apartment on the top floor of Datier, one of the newest developments in Flic en Flac, there is a spectacular view of Le Morne, marred only by the houses in between.

'Construcion sauvage', said the electrician, busy in the apartment. I knew exactly what he meant. When I first visited this area with my Mauritian family in the late 1980's, we foraged for firewood on the very site now occupied by commercial development comprising a hotel, restaurants, shops and apartments that form an almost unbroken chain along the length of Route Cotière. Stretching back from this coast road are the patchwork of morcellements that have rapidly been devoured and from which grey concrete monoliths are now rising en masse from the once virgin landscape.

When complete, the occupants of this labyrinth of buildings will be denied any view other than that of the neighbours gazing into his life behind bars, due to the lattice work of iron grills installed for security in every urban window in Mauritius. This is domesticity on a paradise island.

Negative tourism

Whilst one can justify the need to improve the housing conditions for many of the indigenous population, this insatiable appetite for residential construction is dwarfed by that of the hotel sector. Another four such luxury retreats for the well healed visitor were announced by the Minister for Tourism, the Rt Hon Nando Bodha, on Friday 7th December. If this trend continues unchecked then the net result could well be to destroy tourism not boost it.

The reasoning is simple. Jeanine Wick, whose Villas Pointe Aux Roche at Riambel are to make way for a grander project of the Domaine St. Felix, argues, "With more and more hotels being built in Mauritius we will become like Majorca, then no-one will come here." An argument clearly aimed at the European market who would not travel 12 hours for three times the money just to be packaged into the gridlocked beaches of hotels standing shoulder to shoulder around the entire circumference of the island.

This may be extreme. Certainly some restraint has already been shown, especially in the case of the proposed development of Isle Aux Cocos by Naiade Resorts. But this has not deterred the projects in Savannah or the valley beneath the Domaine du Chasseur from proceeding.

"Between sky and sea laid a paradise ... an astounding site of unique beauty tucked away at the heart of an overwhelming vegetation revealing an authentic oasis of green and a special ground to encounter birds and harmonious wilderness." So begins the promotional literature for the Domaine, as penned by its proprietor, Alain O'Reilly. High praise drawn from his first encounter with this estate nestling in the south east of Mauritius. "A benign calmness overcame me at the sight of this ever-changing scenery always offering new outlines. The 'Domaine du Chasseur', although far from modern civilization and stress is so near my wildest dreams."

Today those dreams include the development of a three billion rupee super luxury 80 room hotel, 80 self-contained villas, a marina and a championship golf course designed by Gary Player. Sitting in the Panoramour restaurant on the summit one could visualise the impact this construction might have on a hitherto unspoilt vista.

"A dream come true with the promise to safeguard the soul/essence of the Domaine," concludes the advertisement. Alain assures me that the Domaine, that I, and many lovers of nature know, will remain untouched. The proposals for the valley will be in keeping with environmental guidelines for 'green' development. The word that has also been adopted by Frederick Leon Robert Jnr when describing the plans for the coastal construction destined for the St. Felix domaine near Riambel.

Preservation

'Far from the madding crowd' - ed beaches of the North, embraced to the South by unspoilt stretches of blue beaches and savage coastlines, sheltered by a fringe of evergreen hills surrounding it, is the district of Savanne," this is their scripted invitation to visit the estate.

It is clear that they have every intention of preserving vast swathes of the 6,000 acre estate in its natural condition. Even if to do so it is economically necessary to sell cross country tours to arguably the islands most spectacular waterfall locked within their private enclosure.

"Hiking along the Plaine Champagne road going through Macchabee forest and the Black River Gorges, the view over the South is breathtaking. Enshrined in the lush greenery of its cane fields gently undulating under the caress of the wind and the blue rollers breaking with all their might over the white panache of smoke, is the Domaine Saint Felix."

These authors may do well to reread their own text before laying the foundation stones for yet more hotels. The real 5-Stars in Mauritius should be rewarded to the natural grandeur of the Black River nature park, the sweeping panoramas witnessed from the top of Grand Bassin, the fury of Soufleur and the many other physical features that once defaced by development can never be replenished.

These opinions are not voiced unilaterally. They are the collective thoughts of many Mauritians, lay people and professionals, including hoteliers, who unanimously aired their apprehensions whilst silently acquiescing to the economic realities. Behind all 'progress' is money. Not economics in its purest sense, but financial reward for the few. Because employing the economic argument of supply and demand should make the decision makers think again. With one or two exceptions the bulk of the Mauritian hotels enjoy only 65 per cent occupancy. To call a halt now to further hotels would also preserve the island's exclusivity which in turn would provide those financial rewards the commercial world lusts

The Delphis Bank Story

Has the Bank of Mauritius taken too drastic a decision in closing down the Delphis Bank?

Has Mauritius been sending the wrong signal to foreign investors?

The new owner(s) of the Bank will be made known at the end of April following the tender invitation by the receiver/adminstrator. The Delphis bank will then be authorised to oprerate anew, it is being speculated.

If the interests of the depositors will be safeguarded, what will happen to the interests of shareholders? The Bank of Mauritius has taken a very serious decision in stopping an on-going concern from trading as a result of which all shares could be wiped out.

So many figures about loans of all sorts, bad debts. loss etc being quoted by the Mauritian press in regard to the Delphis Bank that Finance Minister (and PM in the wings) Paul Bérenger said that what was being reported in the newspapers could not be

A good number of our readers are affected by the demise of the Delphis Bank for the mere fact that their deposits in the Bank have been frozen, and messages received from Mauritius tend to indicate that the situation remains very confused about the fate of the Bank.

Because we have been carrying advertising for the the Delphis Bank in our publication, numerous UK Mauritians have invested in its shareholding scheme and deposited money in its savings accounts. We are being approached by readers to know about development affecting the operation of the bank. Only vesterday (Friday, 5 April) a telephone call informed us that a former top man of Delphis has put his (UK) house, in Millionaires' Row, Hadley Wood, Hertfordshire, on sale for £7m (to pay back a loan from the Bank?). In all our editorial on the Delphis we have always slanted towards investment in Mauritius.

Numerous readers believe that Mauritius Island has been sending the wrong to signal to foreign investors that no investment is safe in the country as a result of the drastic action of the Bank of Mauritius (BOM) forcing the Delphis Bank to cease trading at the stroke of a pen. Yet, in a message about the Country's Cyber Island project, Prime Minister Sir Anerood Jugnauth stated lighted at the very outset. All these facts must be of paramount importance to be brought up at the highest level.


Shareholders' appeal

Some major overseas shareholders appealed to PM Sir A. Jugnauth to intervene which he refused to do. This could well be understood because the PM's and the FM's will have both been consulted by the Governor of the Bank of Mauritius prior to the Delphis Bank being stopped from trading. Those shareholders are said to be having recourse, now, to the Supreme Court of Mauritius against the Bank of Mauritius in its decision to revoke the licence of the Delphis Bank, it is reported. A court action is likely to take some time to finalise.

Mr Bérenger equally told the National Assembly that in neighbouring South Africa, three banks have been forced to close down, and their shareholders have appealed against this decision. He said that Mauritius was watching closely the event in South Africa. Does that mean that Mauritius will simply go by the South African decision in relation to the suspension of the Delphis activities?

Mr Bérenger's uneasiness about the Delphis goes back to 10 years ago when that Bank purchased the Union Bank's interests as a result of its closure by the Bank of Mauritius and when he,

> in the Assembly when crossing swords with Opposition leader, Navin Ramgoolam. Mr Bérenger stressed that this acquisition took place at a time when the Bank of Mauritius was not independent of the Ministry of



What many depositors from England have been asking is why close the Delphis Bank just because two directors have committed some blunders, as indicated by the

BOM communiqué. It would be more logical and appropriate to take action against the directors and not against the Bank itself, jeopardising in the process the interests of thousands of depositors and shareholders, throwing hundreds of employees out of work, while at the same bringing down the reliability of Mauritius as a financial centre. It is argued here in London that the borrowers will have provided collateral security for the loans obtained. Why close down

the Bank then? The Bank has over five billion rupees worth of assets, and a capital reserve of 683 million rupees, why did they close the Delphis?, the UK depositors want to know. The Bank of Mauritius's communiqué talked of "loans irregularly granted" and not of irregularities. Irregularities would have been a matter for the police.



A total of some £600 million have been lost by the Allied Irish Bank over a period of five years as a result of an alleged fraud by a currency dealer of the Bank. Nobody has even thought of closing

down the AIB. Yet, in Mauritius nobody has stolen any money from the Delphis Bank and there has been no rogue trading, so why did they close the bank? Many depositors' savings are at risk, and so are the shareholders' investments. They should not be found in such a situation. Shareholding is a bit of a gamble, everyone agrees to say. A shareholder is expected to lose his investment if a company goes bust, but the Delphis



Bank has not gone bust. So why should shareholders be expected to lose their investment in the Bank at the whims of the Bank of Mauritius? This cannot be right, surely. No one is saying whether the assets of the Delphis, shareholding comprised, will be handed over on a plate to a prospective buyer.

The greatest misunderstanding, we are told, is that a meeting of the Board of Directors with the Governor of the Bank of Mauritius was scheduled for mid-March, but well before that meeting the Governor revoked the licence of the Delphis Bank on March 8. Why could not the BOM have waited?

Not a first

"Mauritius brings together the ideal conditions that makes it an attractive location for doing business." A month has elapsed since the closure order was

issued on the Delphis by the Bank of Mauritius, and yet the Receiver/Administrator designated by the Supreme Court of Mauritius, Mr Raj Thacoor, has still to decide what will become of the Delphis and how its assets are to be disposed of. Rumour has it that at least 10 interested parties have expressed the wish to take over the running of the bank.

In the National Assembly a few days ago, Finance Minister Paul Bérenger said that the Delphis would soon be put back on rail as a going concern. But the Bank was a going concern when its licence was revoked, as we pointed out in our March edition.

Opposition leader Navin Ramgoolam has been asking the FM whether dividends were being paid to shareholders prior to revocation. FM Bérenger, though at first said he had no information to this effect, subsequently declared that dividends were paid by the Delphis to shareholders, as we stated in our March article. aux Bénitiers constitutes a crime against the environment and also a rape of our natural heritage, he said.

According to him, the group's action was not motivated by the fact that hotel development would embarasss fishernmen but because hotel development on the Bénitiers Islet was a true crime against the environment of Mauritius.

Lamarque said a petition against hotel development on the islet was being circulated among the tourists who go picknicking on the islet.

Murder suspects arrested

The Mauritian police have identified three prime suspects in connection with the murder of a taxi driver, Mr Idriss Hossenbocus, aged 65, of Souillac, which occurred during the night of 10 March.

The alleged suspects are LouisJean Marc Jacques aged 32, his wife Marie Savrina Jacques 28 years old, and his friend Marie Claire Prehagg, known as Kamla,

After a two-week intense search by the police, all the three suspects, along with a fourth one, an inhabitant of Curepipe, were arrested on considered as the main suspect, has been provisionally charged with murder whilst the two women will have to answer to a provisional charge of harbouring a criminal. The suspects will be taken to Court again on 8 April next.

The victim's body, partly burnt, was discovered at Dubreuil in Moka district, two days after the murder. It appears that the murderer had killed his victim by stabbing him through the heart before attempting to burn his body. The motive for such a heinous crime is not yet known.



Stamps of Mauritius

Commemorative issue for the 10th Anniversary of the Republic of **Mauritius on March 12**



To mark the 10th Anniversary of the accession of Mauritius to Republic status, the postal service isued a set of four commemorative stamps. The set comprises of stamps of the Re1, Rs4, Rs5 and Rs9 denomintions,

Mauritius opted for the status of a Republic, after gaining independence twenty-four years previous. The satus became effective on 12 March 1992. The President of the Republic succeeded Her Majesty Queen Elizabeth The Second as head of state. The Legislative assembly was renamed National Assembly and all references to the crown was made in the State.

The themes chosen for the stamps relate to Port Development on Re1, Financial Services on Rs4, Water Storage on Rs5 and Road Development on Rs9.

Re1 - Port Development

The development of Port Louis as a hub of the Indian Ocean for trade, warehousing and disribution has led to the construction of numerous guays to accomodate the transhipment of merchandise. The last decade has seen an increase in container handling.

The stamp shows the three quay cranes installed in Port Louis.

Rs4 - Financial services

The Stock Exchange of Mauritius (SEM) was set up in 1989 to further deomocratise access to the stock market. Since then it has witnessed many changes, the last one being the the introduction of The Stock Exchange of Mauritius Automated Trading System (SEMATS) in 2001. It enables local and international investors an oppertunity to obtain maket information and data on a real time basis. An electronic trading system has also allowed investors to trade online through brokers.

The stamp is a compostition showing the use of information technology in the stock market.

Rs5 - Water Storage

This stamp features the construction of The Midalnds Dam, which will be used mainly for irrigating the Northern Plains. The reservior will provide 41 million cubic metres of water annually, which will be distrbuted among, agricultural, domestic, tourist and industrial use in the North. The Midlands Dam is scheduled to be completed by December 2002.

Rs9 - Road Development

Huge investments are being made for the improvement of road infrastructure, due to the increasing number of vehicles using the roads. Carriageways and new link roads to bypass congested areas are being built and existing roads are being widened to make the traffic flow fluid.

The stamp portrays the roundabout at Réduit, a major point of exchange for traffic from the centre of the island.

Raymond d'Unienville, a respected solicitor residing in Curepipe, said he and his wife never went to Grand Baie because of the commerciality. Indeed, when my wife was a child she would walk with her grandmother around the coast from Mon Choisy without encountering a soul. The rapid development is not attractive, as it has given no consideration to aesthetics. Approached from the featureless plains of Goodlands that gradually evolves into a concrete jumble. A similar mistake is now in the making in Flic en Flac where Sheela, the owner of the apartment in Datier, observed that there appears to be no officially conceived urban plan which should include the provision for communal areas, parklands, even playgrounds for the young and the young at heart. Mauritius villages mature into towns without education.

Now even that majestic outcrop of Le Morne could become scarred by the construction of a cable car. Mr Francis Piat's 'Green' project is being awarded the additional endorsement of having the site officially declared "a lieu de memoire." 'A memorial site where people would come and learn more about slavery and pay respect to the former slaves. A special place where silence and meditation will rule in memory of our slave ancestors,' Mr.Piat, said, a museum will be erected at the base and a restaurant constructed on the summit alongside a memorial.

"I sincerely and deeply believe that this nation must pay respect to the former slaves who suffered so much," Mr.Piat continued, "My project is the only practical one submitted so far."

Unfortunately his proposal would not pay homage but would be sacrilege. No matter from which direction one comes upon the vision of Le Morne it is the very nature of it standing stark and foreboding against the sky and sea that is the true memorial to those who died so tragically there, which should be preserved at all costs.

Leaning towards support of the cable-car project a government insider posed what he conceived as a rhetorical question, 'How (else) do people get up there?' - to pay their respects. They could, of course, emulate their ancestors suffering and climb up there. A far more fitting tribute that would afford those who made the sacrifice a greater understanding of what their forebears endured. The descent, however, I would suggest should not be so rapid or final.

Mauritius, that promotes itself as a paradise island, should conserve what natural paradise remains. If not, then those who seek to despoil it for short term material gains may well suffer the long term consequences of falling from grace with the same degree of fatality as those 'ancestors' who leapt from Le Morne rather than face retribution

La 8e Èdition de MINEDAF à Maurice en décembre

Maurice accueillera en décembre prochain la 8e édition de la Conférence des ministres de l'Education des Etats-membres d'Afrique (MINEDAF VII). L'objectif de cette conférence est de renforcer la coopération multidimensionnelle pour le développpement de l'éducation en Afrique.

"Il s'agit aussi de coopération entre pays africains eux-mêmes que celle entre les pays africains et les partenaires au développement", a déclaré un officiel au ministère de l'Education.

Il a dit que MINEDAF VII annonce des enjeux cruciaux et se présente non comme une simple conférence de plus à ajouter sur la liste "mais comme le point de transition d'une période à une autre."

Selon lui, malgré les avancées realisées depuis la Conférence mondiale sur 'l'Education pour Tous' tenue en 1990 en Thailande, 100 millions d'enfants, dont une majorité de filles restent exclus de l'éducation à travers le monde.

"Il urge de trouver une solution satisfaisante à la situation de ces enfants, si on veut leur épargner le sort des 875 millions d'adultes analphabètes recensés actuellement à travers le globe, étant entendu qu'au niveau de ces chiffres, l'Afrique se distingue négativement", a-t-il souligné.

L'UE finance les petites et moyennes entreprises

L'Union Européenne a accordé une somme de Rs 58 millions en vue de souscrire au capital des petites et moyennes entreprises mauriciennes à hauteur de 49%.

La Banque de Développement de Maurice (BDM) et la Corporation d'Investissement d'Etat contribueront chacune Rs 10 millions à cette démarche. Selon un officiel mauricien, les entreprises en question peuvent obtenir de l'aide pour améliorer leur processus de production, leur système de gestion et de marketing, entre autres.

"Si l'entreprise se trouve devant un besoin urgent de formation de son personnel les responsables de l'exécution du programme vont l'aider à concevoir un plan de formation

L'Union Européenne a avec la participation d'une accordé une somme de Rs 58 millions en vue de souscrire déclaré l'officiel.

Une page d'histoire: Personnalité du passé

Curé, le redoutable lutteur, le démocrate intrépide ...

"Il ne peut exister à Maurice, un autre genre de nationalisme que le nationalisme mauricien et je crois y avoir contribué en groupant sous une seule bannière la grande majorité de mes compatriotes d'origines différentes"

Dr Maurice Curé, 14 décembre 1938

L'évènement le plus marquant de la première moitié du 19ème siècle est, sans conteste, le soulèvement de la masse, la classe ouvrière. Tôt ou tard, la protestation contre le système électoral restreint était attendue car il ne donnait pas de chance égale à tout un chacun de

briller par son talent politique.

Mais toute la classe ouvrière se réveilla lorsque le Docteur Maurice Curé, battu aux Elections Générales, alla à sa rencontre pour chercher support en vue de se venger sur les capitalistes; les forces cachées et les aspirations de la masse se réveillaient tout à coup. Une révolte venait de naître ...

Dr Curé, le combat politique Maurice Curé, lauréat de 1907 du prestigieux Collège Royal, fut sans conteste, celui qui appela les grandes forces du travail à la contestation

Il eut une carrière politique qui

semblait être connue par les mêmes esprits que furent Rozemont, Anquetil, Ollier ou Ramgoolam. Le 23 février 1936, le Parti Travailliste fut créé par le Docteur Maurice Curé et le Pandit Sahadeo fut le premier secrétaire général du parti.

EmmanuelAnquetil, le Pandit Sahadeo Rama et le Docteur Maurice Curé ont défendu de façon remarquable les principes du Parti Travailliste et leur apport a une valeur permanente. Maurice Curé était avant tout un meneur, un cerveau, un organisateur. Il prenait toutes les décisions importantes, élaborait les demandes, passait des résolutions.

Il voulait que la classe ouvrière de l'Ile Maurice jouisse des mêmes droits et conditions de travail comme ceux recommandés à la conférence du Bureau International du Travail. Il avait l'audace de lancer un défi aux autotirités de la classe blanche en créant le Parti Travailliste.

Soudain, il y eut un réveil sans précédent de la classe ouvri'ere si bien que le Gouvernement n'avait d'autre choix que d'accepter les changements et de céder aux demandes de la population. La réforme de la constitution pour assurer la représentation de la classe ouvrière fut une revendication maieure du Parti Travailliste.

Le parti s'est aussi battu pour l'octroi d'une pension aux personnes du troisième âge. Le suffrage universel pour tous les adultes avait été officiellement demandé par le Docteur Maurice Curé lors de sa déposition devant la Commission Hooper après les grèves sanglantes dans l'industrie sucrière.

En effet, 1937 fut l'année des grandes grèves où les travailleurs, sous la férule du Parti Travailliste et avec l'aide de Bissoondoyal, combattaient dans un remarquable esprit d'unité et de solidarité. Les remous des Syndicats au mois d'août de 1937 ont forcé le Gouvernement à modifier les conditions d'emploi des travailleurs à la demande du Dr Curé.

Une Commission d'Enquête menée par Hooper recommanda des salaires plus élevées aux laboureurs ainsi que la création

d'un Bureau du Travail. De plus, il était désormais légal pour les travailleurs de se syndiquer.

En 1938, la loi du Travail approuvait la formation de mouvements syndicaux. Ramgoolam entretint des contacts réguliers et permanents avec le Dr Curé et le Pandit Sahadeo, et à leur requête, faisait valoir leurs points de vue au Conseil Législatif.

Parallèlement, le Gouverneur Sir Bede Clifford n'appréciait pas que Curé prit la paternité des réformes apportées dans le domaine du travail. Il semble que le Gouverneur voulait partager la gloire obtenue dans la réalisation des réformes.

Il essaya de dominer le Parti Travailliste en se servant du poison communal pour éloigner les laboureurs Indiens du Docteur Curé, un membre de la population générale. Comment Dr Curé pouvait-il être "indophile", défendre les intérêts des Indiens?

Le Gouverneur semait la division et se servait de la conjoncture pour projeter en avant certains intellectuels Indiens. Sir Cliffort tint le Dr Curé et le nouveau Parti Travailliste responsables des nombreuses revendications qui affectèrent les plantations.

Curé déclara ouvertement la guerre contre les Oligarques. En effet, les travailleurs étaient d'opinion que les conflits dans l'industrie sucrière ont apporté une plus grande crédibilité au Parti Travailliste qui rassembla plus de 20,000 sympathisants au Champ de Mars le 1er mai 1938.

A cette date, Curé avait été rejoint par Harryparsad Ramnarain qui renforçait les bastions rurales avec la création de "Agricultural Workers Union". On pourrait dire que le Dr Curé a devancé l'élite de la communauté hindoue en réussissant à railler autour de lui des sympathisants de la classe ouvrière hindoue.

Il manquait un dirigeant de la taille de Rémy Ollier ou De Plévitz, un homme de la masse, un prolétaire pouvant faire face aux défis. Même les Arya Samajists étaient impatients et voulaient se rallier derrière quelqu'un, peu importe le groupe ethnique; ainsi ils acceptèrent le Dr Curé, une personne de couleur.

Le porte-parole de la classe ouvrière fut arrêté et traduit devant un tribunal après les grèves qui eurent lieu. Le verdict de la Cour fut certes favorable à Curé, mais l'insuffisance de la peine avait pour le plaignant le caractère d'une humiliation.

Contre les assauts qui venaient de toutes parts, Maurice Curé cessait le combat contre lui, l'ingratitude avait sorti toutes ses flèches. Et pour rendre la douleur plus amère, il devait, de sa retraite, voir quelques uns de ses protégés de la dernière heure porter leur loyauté jusque sur la tribune de la faction la plus conservatrice de l'opinion locale. Ainsi l'exigeaient les stratègies du combat politique.

VAT will go up

Finance Minister and Deputy PM, Paul Bérenger, announced at a press conference that VAT will go up from the present 12% for the simple reason that the government will need to reduce the budget deficit which is estimated at 7.8% of the gross national product.

The nation will have to wait until the Finance Minister's budget speech to know the exact amount of the increase but he made it known that the measures will be tough.

The country is at a critical juncture, he said, and massive investment is required in the fields of education, information technology, housing, communications, environment etc.

The Opposition Labour Party has criticised the government's negative economic performance and finds no justification that VAT should be inflated by Finance Minister Bérenger.

The Civil Service Federation states that Paul Bérenger has disqualified himself as Finance Minister as a result of the proposed VAT increase and the Delphis Bank scandal. The Federation's chairman argues that a reshuffle of the Cabinet is necessary and the Finance Minister should be shifted to forestall a social crisis in the country.

Association Chrétienne des Mauriciens à Londres (ACML) celebrates 35th anniversary

In the early sixties, soaring unemployment in Mauritius and the idea that the grass is greener in England, drove many of us Mauritians to leave our beloved country to seek fortune here. The immigration "open Door' policy to Mauritians then and the cushion provided by the Social Security benefits immediately after arrival, were other factors that pushed the hesitant ones to make the move.

After our arrival here, we soon realised that, after all, life is not a bed of roses here: many of us who were mollycoddled at home by our parents and, hence, shielded from cooking, washing, shopping etc, found ourselves on our own having to cope not only with these daily chores, but also with our work and, for some, evening classes too.

Life was a constant struggle in a country whose environment, climate and culture were totally alien to us. Some, naturally, did make their way back home, but the majority, the resilient ones stayed on despite the hardships.

Among these, many regular churchgoers on Sundays were attracted to the Notre Dame de France Church, where the mass, said in French, gave them 'le sentiment d'appartenance' and also the opportunity to meet other Mauritians after the service, just like they used to do in Mauritius.

These Sunday meetings gradually attracted more Mauritians and one of them, the late Antoine Marcel, had the inspiring idea of forming a Group to help each other mutually and also, to help any newly-arrived Mauritian finding his feet here. So, after a plausible recruitment drive by Antoine, Paul Mamedy and a few others, the ACML was formally launched in

Thus was born the ACML and, based at the Notre Dame de France Church, it gave us the 'god-sent' opportunity to meet over a drink, at least once a week, to share in our own language, our various experiences of the week.

Since then, 35 years on, the ACML has gone through many ups (let's forget the downs). Indeed, it has had the honour of welcoming and entertaining many VIPs such as: HRH the Princess Anne (14 March 1972), Sir Seewoosagar and Lady Ramgoolam, Sir Aneerood and Lady Jugnauth, His Eminence the Cardinal Margéot, Sir Satcam and Lady Boolell, Sir Gaetan Duval and Xavier Duval, the past and pre-Mauritian Commissioners, priests from Mauritius for our annual Père Laval mass etc.

For their services to Notre Dame de France Church, both Antoine Marcel and his wife Maud were twice decorated by the Pope; our former legal adviser, Me Michel Koenig and our Aumônier, Père Jacques Coupet were both made Chevaliers de la Légion d'Honneur.

But, the ACML really excels in charitable activities. Immediately after the riots in February 1999, it was the first association here to launch, in Mauritian newspapers, an appeasement appeal to our compatriots; it also raise £3,000. through collections for the victims of the riots.

At a meeting in Government House after the last general election, our Prime Minister took some time off from his busy schedule to thank an ACML delegation for its praiseworthy activities, not only within the Mauritian community, but also in the promotion of our 'rainbow' identity in our adopted country.

Throughout these years the ACML has remained alive to the social and spiritual needs of its members and, within its means, has always sought to help any unfortunate Mauritian knocking at its door for help. Every year, the ACML makes, among others, a donation to the Père Laval Centre in Mauritius and also to the Société de St Vincent de Paul in Leicester Square, which counts many Mauritian pensioners among its members.

Nowadays, the ACML remains apolitical and, despite its name, welcomes as member any Mauritians, without distinction of colour, religion, community, socioeconomic status and sex. Its attachment to the Notre Dame de France Church is as strong as ever, its members are all volunteer to help the Church in any way; its management committee members are all volunteers, freely devoting a lot of their times and efforts, in the furtherance of the ACML aim to help other Mauritians in dire straits. We organise visits to the sick either at home or in hospital to alleviate their sufferings or loneliness; when asked, we can also arrange for spir-

Not surprisingly, the ACML popularity, rightly acquired through its celebrations Mauritian and family events and its benevolent actions, is widespread and at times makes the envy of others. We wish to appeal here to all likeminded Mauritians to join us at ACML in our benevolent activities; membership costs only a miserly £5. per year. This is vital for its survival: we must not allow what is an asset to our community to disappear.

Admittedly, ACML would not be celebrating its 35th anniversary today, were it not for the continuous support of its past and present members, friends, sponsors and the hierarchy at the Notre Dame de France church.

Therefore, we would like to express here our sincere gratitude and thanks to everyone of them. However, for their assiduous devotion to the ACML, our special thanks must de dedicate to the late Antoine Marcel and Lucien Charlotte who were respectively, President, and last but not least all the past and current management committee members. who have been long serving and zealous members of the ACML.
