

Rodrigues' first foreign diplomat Paul Draper MBE appoint gets its facts Honorary British Consu wrong about



In the process of its devolution programme the Mauritius Government has decided to grant the outer island of Rodrigues its own regional legislative assembly. Election of members to the assembly is scheduled to take place on September 29.

It is perhaps in view of this constitutional development of Mauritius's distant island (located at 350 miles away from its own shores) that the British Government has decided to appoint a honorary consul with residence in Rodrigues.

The British Government's choice has fallen on British-born Paul Draper MBE who first went to Mauritius in the early seventies.

In the 1960s Londoner Paul Draper befriended a few Mauritian migrants in the UK and started to learn the Creole language. By the time he went to Mauritius in the early seventies he had already mastered the language and when he landed at the Mauritius airport the authorities feared that they might be dealing with some sort of foreign agent, it was reported.

But Paul, a close friend of the late Bishop Trevor Huddleston was much more of a missionary and social worker than a foreign agent though his present title of Honorary Consul has the flavour of one of those spy novels of Graham Greene or John Le Carré!

Well, from the very moment Paul Draper set foot in Mauritius some 30 years ago, he dedicated himself to voluntary welfare activities among the disabled to make them self-sufficient through the apprenticeship of various handicraft activities. Today his Craft Aid institution both in Mauritius and Rodrigues are providing employment to several severely disabled nationals of the two islands.

"The Honorary Consulate's work will be an important extension of the British High Commission's activities. Its establishment reflects growing engagement by Britain in Rodrigues as well as the island's increasing attraction as a tourist destination, with the expansion of air links. The Consulate will provide consular assistance to British nationals in Rodrigues and help coordinate High Commission activities in the island," said British High Commissioner to Mauritius, Mr David

Of the choice of Paul Draper himself, the High Commissioner said "Paul has worked on the island for 18 years and is the most wellknown British personality around. It is particularly fitting that somebody who has given so much through his work at Craft Aid, and through the employment of handicapped people and the school he runs for deaf children, should be our Honorary Consul."

Newsweek Chinese coolies

In Newsweek (USA) issue of August 12, under the heading THE NEW **COOLIES, Brook Larmer** wrote "more than 100 years, Chinese coolies were recruited to harvest sugar cane in Mauritius." This is a wrong statement since the Chinese never came to work as coolies in Mauritius especially on the sugar plantations.

In fact, Chinese migrants came to Mauritius on their own accord as traders. Today, the Sino-Mauritians, as a minority group, wield considerable economic power, at par with any other section of the Mauritian society.

If Brook Larmer got this bit of her article wrong, one could be forgiven to entertain some doubt about the rest of her contribution to Newsweek on the tribulations of the Chinese girls who were imported to Mauritius during the past few years as a result of a manpower shortage in the island.

"We were treated as slaves," the girls told Newsweek, "stitching pockets into Hilfiger jeans for 14 hours a day, seven days a week, 365.2 days a year."

It must be acknowledged that at a garment factory owned by a group of Hong Kong industrialists, Chinese girls had been complaining about their conditions of work and their pay.

Following the death of two girls, the workers went on strike and some were repa-

The girls in China are now seeking compensation, on various grounds, from the recruiting agent in China and from the Hong Kong factory owners.

Women marching to draw attention to the spate of rape incidents in Mauritius



Women have been marching to denounce the sexual violence against them which has been taking place in Mauritius for some time now. The most recent attack took place during the night of July 16 at the seaside resort of Blue Bay when a woman's house was burgled by two intruders who after taking her money sexually assaulted her.

Their crimes accomplished, the rapists gagged the woman and took her with them in her own car to prevent her from calling the police.

The car broke down at La Vigie on the way to Curepipe and the two rapists left their victim by the wayside.

The distressed woman stopped a passing car for

assistance during the early hours of the morning and two of the six occupants agreed to take her to the police while the other four who were under the influence of alcohol preferred to wait on the spot for their return.

But instead of taking the woman to the police the two characters in turn sexually abused her.

At least 10 cases of rape have been reported since the beginning of the year. On July 24, serial rapist Gerard Agamenon - known locally as Dr Miko - was sentenced to a total of 72 years for the rape of five women.

It is against this sort of background of violence towards women that the march was organised to highlight the dangerous situation prevailing in the island.

More victims on killing roads

On Saturday, August 7, a cyclist, Luc Bozelle, was knocked down by a car on the road at Argy in the Flacq district. The post-mortem revealed that he died instantly from a skull fracture and excessive draining of blood in the head.

On Sunday, August 11, 13 years old Mishal Beharry

on holiday in Mauritius with his parents died in a road accident at Triolet when the car in which he was travelling at 2am and driven by his mother hit a stationary

The mother was not injured, it is reported. Mishal was the son of Prakash Beharry, a senior official formerly attached to the Mauritius High Commission in

The latest casualty (at the time of going to press) occurred on Wednesday, August 12, and involved 22 year old Shivani. equally on holiday at home. She did her Architecture studies in Malaysia.

She was to fly to the UK in September for further studies at the University of Kent.



The Delphis Bank story

An obsession or a call for justice?

"From your recent edition, you have dedicated a lot of space to the loss of Delphis Bank and Shareholders' capital. Having obtained a recent copy of the shareholders' list, it is difficult to comprehend your paper's obsession when less than 12% of the investors live in the UK. At least, they can claim a capital loss on their UK Tax Return for this year."



An on-going and profitable concern driven to the wall purposely?

The above text is part of an email that has been sent to us by someone whose name we have decided to withhold from publication.

We are grateful to him for his tax advice for what it's worth but we must say that in every article we have written on the Delphis Bank scandal we have talked of the interests of shareholders in general though our thoughts were particularly with those who were influenced by our past editorial and the publicity we carried

Shareholders hard-hit in this Delphis scandal

Deputy Prime Minister and Finance Minister Paul Bérenger has been saying it was public knowledge since 2001 that the chairman of the Global Finance Direct had made it known that he wished to buy the Delphis Bank (We said the same thing in our July issue.)

Well, since it was the intention of the chairman of the Global Direct Finance to acquire the Delphis Bank why did he not, as they do in all reputable financial centres, put in a bid officially for the bank, signifying his intention either to buy or take over the Bank. Is there no Takeover Panel or an Office of Fair Trading in Mauritius to prevent such a scandalous situation as the destruction of the Delphis bank and the sale of its assets estimated at 600,000 million rupees for just Rs50 million. (If they sit long enough on the Rs50,000 the money might start incubating.)

A legal and legitimate bid would have enabled the Delphis Bank shareholders to have a say in the disposal of the bank. The decision to accept or reject a bid must rest with the shareholders, and it is a known fact in the business world that a bid for a company is an opportunity for shareholders in general to make some profit in regard to their investments.

In the case of the Delphis Bank, instead of a bid from a prospective buyer, the **connivers** decided to deprive the shareholders of all their rights by putting the Bank into receivership. Overnight the shares became useless, yet the bank itself never filed for bankruptcy.

Has the Bank of Mauritius acted *ultra* vires?

Many people have always refused to accept that the Delphis Bank was in receivership. We ourselves have always referred to the 'Bank in administration', and that what it actually was. The Port Authority, as an interested party, may have had the right to challenge the solvency of the Delphis Bank but the Bank of Mauritius was not right to put the Bank overnight into receivership. While determining the solvency of the Delphis Bank at the request of the Port Authority, the Bank of Mauritius should have put the Delphis into the care of an administrator.

Receivership could only have happened if the Bank was found insolvent. But at no time was the Delphis Bank insolvent. Inviting applications for the acquisition, the so-called receiver manager Mr Thacoor stated that the Delphis was the fifth fast-growing bank in the country. In his letter to prospective partners the Chairman of the Global Fiance Direct stated that the Delphis was an on-going profitable concern.

In its issue of March 9, the Mauritian daily paper *l'express* stated that in 1998 the Opposition had declared that there was a suspect tie between the Bank of Mauritius and the Delphis Bank. It came as little surprise to many that, once these people came to power, the Bank of Mauritius should revoke the trading licence of the Delphis Bank. However, it is felt that that in trying to settle score with the Delphis Bank (for reasons best known to themselves) some people fell into a trap and unwittingly made of the Delphis Bank an easy prey for the connivers and the predators. Today, in spite of themselves, they still have to condone a very scandalous situation and defend those who have openly expressed aversion to the kind of people who may in future hold the office of PM.

Incubation

Four months have elapsed since the sale of the Delphis Bank and yet the Receiver/Manager has not written to shareholders to inform them of what he intends to do about their investments to create the assets of the Delphis Bank.

In a letter to depositors, Mr R. Owadally writing on behalf of the First City Bank Ltd states:

"(a) FIRST CITY BANK LTD (formerly known as DEL SUBS COMPANY LIMITED) has been duly licensed by the Bank of Mauritius to carry on banking business in Mauritius.

(b) By virtue of two deeds drawn up by Me.Darmalingum Goorriah, Notary Public, on the 16th April 2002, and 25th April 2002 and transcribed in Vol.4880 No5 and Vol.4880 No.6, respectively, THE DELPHIS BANK LIMITED (In Receivership) acting by and through its Receiver / Manager, has sold, handed over, transferred, assigned and delegated to the DEL SUBS COMP ANY LIMITED (now known as FIRST CITY BANK LTD), its undertaking and banking business, including the rights and obligations under (a) the deposits received and (b) the loans, advances and credit facilities extended, by THE DELPHIS BANK LIMITED (In Receivership) together with all the mortgage rights and all rights secured by fixed and/or floating charges and/or any form of guarantee and security, including life insurance policies, fixed Deposits, etc., the whole more fully set out in the aforesaid notarial deeds. As a consequence of the above, FIRST CITY

BANK LTD do hereby confirm that it will honour all its obligations in respect of your accounts and/or deposit(s) together with its accrued interest on its respective date(s)." Here again no mention is made of the Delphis shareholders who invested to create the liquidity of the bank for job opportunities for past and present employees, and to attract the predators (an expression well-known in the business world).

What is to be done now?

The chairman of the Global Finance Direct has got 'his bank', as he calls it; there is no political upheaval on the horizon to upset the power-sharing arrangement, and everyone seems very happy including the usual muck-rakers as well as the influential press against the background of a gross injustice. It is now left to the Shareholders themselves to decide on the course of action to follow.

A member of a World Business organisation in the City of London with whom we have discussed the disposal of the Delphis Bank assets, and whose observations have been incorporated in this article, has further expressed the view that there is enough controversial subject matter in this Delphis Bank issue for financial management or company law students to analyse and dissect. Who knows, we may find the Delphis Bank story on an examination paper one of these days. A Mauritius News article has been in the past used by an Irish Examination Board on a questionnaire, (We did publish the Board's request for release of copyright.) It has been announced that Barclays Bank (Mauritius) has renewed a bid to take over the French bank BNPI operating in Mauritius. One may wonder why bother to make a bid when the country has established a precedent of how a bank can be acquired on the cheap by depriving the shareholders of their invest-

More than 10,000 mourners at State funeral

One of the most loved and respected spiritual Leader of the Muslim community in Mauritius and a well-known Islamic scholar with followers in numerous countries, Mowlana Mohammad Ibrahim Khushtar, Siddiqui, Razvi, died on Thursday, August 15, 2002 in Port Louis at the Sunni Razvi Academy, surrounded by his nearest and dearest. He was 81.

Some decades ago he himself incepted the Academy for the spiritual well-being, Islamic education and religious practices (including Zikr and Mowlood) for the benefit of the Muslims of Mauritius and the neighbouring areas, La Réunion, Madagascar, Comores, Seychelles, South Africa and other southern, central and eastern African countries. The State funeral decided by the Government with the consent of the deceased families, was held after the Friday prayers (Jum'ah) on August 16, and the burial took place at the

Eid-Gaah in Vallée Pitot, Port Louis,

attended by thousands of grateful

mourners from all communities and

sources and sound logic. His vast contribution to the spiritual, educational and social development of the Muslim community, is acknowledged with gratitude by a large section of the Mauritian nation.

Without doubt, Mowlana Khushtar was in the same line with great legendary figures of the past, such as the late Mowlana Abdullah Rashid Nawab, Makki, in the 1920s and 30s, founder of the famous Muslim High School in Port Louis, who among other initiatives, pioneered the then new revolutionary teaching methods in Islamic education in Mauritius, Burma, Sri Lanka, India.

Mowlana Khushtar could be compared with the most popular and charismatic Islamic Missionary, the late Mowlana Shah Mohammad Abdul Aleem, Siddiqui, around the 1930s and 40s, and some other Islamic luminaries, including Professor Mallick in the 50s.

Mowlana Khushtar who around mid-seventies moved to England

Most of them have since disappeared from the scene, while the victim is today honoured with State funeral and showered with love from the masses

Jugnauth, Deputy PM Paul Bérenger, The Lord Mayor of the City of Port-Louis, His Worshipful Mr Moorgess Veerabadren, Opposition leader, Dr Navin Ramgoolam, the Pakistan High Commissioner and Diplomats from other countries, Heads of different religious denominations, Ministers, MPs, Councillors and representatives of various professions, trades and organisations.

The creation of the Eid-Gaah itself, with the beautiful Masjid and Madrassa situated in the picturesque valley at the foot of the majestic Moka mountain range, was another unique idea and creation of the Mowlana on this vast plot of land offered to him by the Government for a nominal amount of One Rupee, to be in line with Islamic rules: No mosque should be built on land donated free, it should be on land bought for this specific purpose for the use of the Muslim community (Ummah).

In the mid-sixties, Mowlana Khushtar, came to Mauritius to be the Pesh Imaam (Grand Priest) and Khateeb (Preacher) of the Jummah Mosque at Royal Street in Port Louis where his regular sermons (Khutba) and Waez (religious lectures), most of the time broadcasted on the radios and TV, were followed with great interest not only by the Muslims but also by members of other communities, young and old, men and women, in Mauritius and beyond.

He was known to be a powerful and knowledgeable speaker, with deep conviction in his arguments, always supported by authoritative and settled with his extended families in Manchester, continued to develop Sunni Razvi circles besides Mauritius, throughout the U.K, France, South Africa, Malawi, Zimbabwe and elsewhere. He travelled widely around the world. Although born in Pakistan, he subsequently adopted Mauritius as his own 'native' country, of which he became proudly a naturalised citizen. His base for all his actions has always remained Mauritius, which he used to visit regularly and stayed for long periods of time.

Hence, one of the Mowlana's last cherished wishes was to travel back one more time to his beloved Mauritius, which he did with determined insistence some months ago, though in very poor health. The Almighty Allah has decided that this should be his last journey in this world. He will be missed by all his loyal, sincere and devoted followers everywhere, who will In' shaa'Allah pray the Almighty for him.

Innaa Lillaa-hi Wa Innaa Ilayy-hi Raaji'oonn! May the Creator accept the mission accomplished by the Mowlana and Bless him with Jannatul-Firdawss! Ameen!

Tolerance

research. Man is not violent by nature. Intolerance is not ' in our genes '. Fear and ignorance are the root causes of intolerance, and its patterns can be imprinted on the human psyche from an early age. Mr Frederico Mayor,

The aim of tolerance is peaceful coexistence. While tolerance recognises individuality and diversity, it removes divisive masks and defuses tension created by ignorance. It provides opportunity to discover and remove stereotypes and stigmas associated with people perceived to be different because of nationality, religion or heritage.

Just as a gardener recognises characteristics of each variety of seed and prepares the ground accordingly, a tolerant person takes into consideration the uniqueness of all people. Through understanding and open-mindedness, a tolerant person attracts someone different, and by genuinely accepting and accommodating that person, demonstrates tolerance in practical form.

As a result, relationships blossom. The seed of tolerance, love, is sown with compassion and care. The more one becomes loving and shares that love, the greater the power in that love.

When there is lack of love, there is lack of tolerance. For instance, the example of mother and child: when an obstacle comes to a child. because the mother has love for that child, she is prepared to and has the power to tolerate anything. At that time, she does not worry about her own well-being, but uses love to confront all circumstances. Love makes anything easier to tolerate.

The family is the first classroom to learn tolerance, as there are always some adjustments to be made to accommodate others. School is the second classroom. However, tests of tolerance are taken each and everyday of one's life. Tolerance is inner strength which enables the individual to face and transform misunderstandings and difficulties.

The power of tolerance should be used as a shield of protection since it cultivates the ability to cool the strong and heated feelings of others. Certain circumstances often demand tolerance. Bodily pain can be an example. Indeed, advanced medical treatment has done wonders in helping individuals tolerate pain.

Yet, such benefits do not mean that discomfort is eliminated completely. At some level, tolerance becomes an indispensable power to cope. What would the world be like if everyone was tolerant, if everyone created spaces of mutual respect through mutual understanding? In fact, tolerance develops the ability to accommodate the problems of everyday living.

To be tolerant means to respect our neighbours' opinions, rights, religious beliefs and above all, to hon-

our their worth. Respect should not be measured by physical and material factors like caste, colour, race, religion, sex, nationality, status or popularity.

Tolerance also means appreciating diversity, harmoniously coexisting and supporting one another. One note of disrespect can cause unity to be broken. Sometimes, even in little matters, people quickly get upset, aggressive, angry or violent; they then isolate themselves into subgroups, producing dissension and

Tolerance, a value instilled by the family, the 'school of character', starts at home, is developed further during schooling years and finally, contributes towards making a peaceful world. People say they want peace in the world, but what kind of peace do they desire?

People ask for peace, but whose responsibility is that? Can anyone who remains peaceless be an instrument for peace? Authenticity of action depends on authenticity of person. And the root of peace is tolerance.

Without tolerance, peace becomes only a utopic term. We are at a crossroads of human civilisation. Things are rapidly disintegrating; values are in the ascendant. That is made bitterly apparent by wars, civil strife, riots and ethnic cleansing.

In Ireland, the war which has been going on for decades is due to the intolerant attitudes of people who fail to respect the religious beliefs of others; indeed, the ongoing war between Catholics and Protestants show that the people are religiously intolerant.

Tolerance is the foundation, the major building block upon which a functional stands. Tolerance, leading to Peace is the prominent characteristic of what we call " a civilised society", and the character of a society can be seen through the collective consciousness of its members.

Pig breeders asked to change job

A government committee has invited pig breeders in the island to shift their operation to construction. tourism. transport entrepreneurship. Aid from several institutions have been proposed to them.

"They would also benefit from training in their respective fields", he said.

According to the committee, conditions in which pork are breeded are very poor and against the laws of the country. "They are found too close to inhabitated areas", the committee member said.

London's population to reach 700,000 by 2016

According to the new Mayoral report, London is growing at a considerable rate. It is estimated that by 2016, the population is set to reach 700,000.

The mayor's report "planning for London's growth", suggests that London's increase in population, is the equivalent of adding a borough the size of Islington every three to four years.

These figures also suggest that by 2016, employment in London would have risen sharply with more than 40,000 additional jobs in business services. There will also be a job cluster effect as a result of this, as primarily financial and business services, will be concentrated even more in the centre of the City. Without investment, this would mean the cost of London offices would rise, to more than they are today.

The Mayor of London, Ken Livingstone, said, "These figures show that London's growth is by

far the biggest regional issue in the UK. Population and employment growth on this scale demonstrates London's success and it is good news for the economic and social vitality and for the wider UK econ-

This will also lead to more pressure on public services, such as housing, the environment, transport and others.

Crucial decisions London's infrastructure must be made now, as the services are already suffering the effects of under-investment.

In the last two years alone, the capital has gained about 190,000 more people, and this rapid growth stands out compared to other UK cities and urban regions.

The Mayors 8.1 million population projection is substantially higher than the 1996 Office for National Statistics, as they envisage a population of 7.6 by 2016.

London before London exhibition

A new prehistoric gallery at the Museum of London will be opening on Friday 18 October. It will explore the Thames valley long before the capital even existed.

London before London will take visitors back over half a million years, from when hippos and elephants roamed Trafalgar Square to when Heathrow Airport was an Iron Age Settlement and people measured their time by the phases of the moon.

London before London, traces the relationships between people and their surroundings. The Thames is the central part of the story and to the lives of the communities who live alongside its banks. The river provided water for cooking and cleaning, endless supplies of food, an altar for religious offerings and sacrifices and the last resting place of the dead.

In the centre of the gallery, a

"River Wall", will feature almost 500 objects recovered from the Thames bank, including numerous bronze and iron swords reflecting its role as a sacred river.

London before London will challenge the stereotype of the noble savage, hunting wild beasts with clubs and living in caves. Sophisticated communities established extensive trade networks and adapted to their environment in order to survive.

Displayed in the gallery are a range of carefully fashioned tools and weapons that formed the backbone of daily life - used in everything from cooking to construction.

Status symbols of wealth and power show that hierarchical systems existed even in prehistoric times, perhaps the ultimate possession was a 6,000 year old jade axe especially imported from the Alps.

Living in Constant Fright

Marie, a 34-year old Mauritian and mother of four children aged from 4 to 14 years, is a divorcee since two years ago. However, her children and herself are still standing in awe of her ex-husband being given that the latter still calls on them every now and then.

Six months after her marriage in 1988, Marie's ex-husband started to harass her. He insulted and assaulted her. The situation worsened when money was short in the household. Marie was working as a machinist during that period. In December 1991, she had been victim of a road accident while running away from her husband's assault with her 18-month old baby-girl in her arms. The baby died in hospital three days after the accident. Even the children are not spared by her husband.

Marie declares that she had sought help from the "SOS Femmes" Centre of Moka on several occasions but each time she had had to go back to her husband as she was not authorized to stay at the Centre for more than three months. She had nowhere to go.

Very often Marie's husband took half of her Rs 1400/- monthly salary to have a good time in the company of his friends. Fortunately she obtained her divorce a couple of years ago. Nevertheless, she is still afraid of him. Marie is currently having a hard time, being jobless. Her only source of revenue is a meagre monthly allowance of Rs 2 040/- from the Ministry of Social

No case to answer

Ten people accused of rioting after the football match opposing local club Sunrise FC and Egyptian club, Zamalek, March 24 1996, would not be sued in Court.

The decision came July 12 last from the Director of Public

Prosecutions (DPP).

Meanwhile, another accused pleaded guilty of participating in a riot that occurred at Vallée-Pitot. He was sentented to two years' probation and had to furnish two bails worth Rs 10 000 each.

Foreign reserves on the rise

Mauritius foreign reserves rose to Rs 30 billion at end of June last as against Rs 22,6 billion as at June 2001, according to the latest bulletin from the Bank of Mauritius published July 21 last.

«Net reserves have continued to rise and reached Rs 39,4 billion in May last or the equivalent of 35,9 weeks of imports», it said.

Meanwhile, the USD was exchanged at Rs 30.28 in June last as compared to Rs 30.41 in May and Rs 30.49 in April.

The Euro was exchanged at Rs

27.89 in May and at Rs 28.91 in June and the Pound was exchanged at Rs 44.41 in May and at Rs 44.87 in June.

According to the Bank, the rise in the exchange rate of the Euro and the decline of the USD will benefit to several sectors of the island's economy - free zone, tourism and the sugar sector.

It estimated that revenue per tonne of sugar sold would bring around Rs 14 000 as against Rs 12 500 as estimated earlier.

MTPA wants 45 000 more tourists

Tourism Promotion Authority (MTPA) needs some 45 000 more tourists this year to fill the 1500 additionnal rooms that would be available December next so as to bring the room occupancy rate to 70 percent.

Official figures showed that

last vear the island attracted 660,000 tourists and 322,000 for the first semester of the year.

One official at the MTPA said July 14 last that the authority would participate in 22 operaduring the 2002/2003 tions tourist season.

Mauritius to offer Rs 330 million to Madagascar

Deputy Prime minister Paul Bérenger said last July 20 that Mauritius would offer Rs 330 million (Rs 300 million as credit and Rs 30 million as grant) to the government of Madagascar to help it boost up the economy of the

At a meeting with the press, Bérenger was very critical of African governments who had not recognised the new government in power in Madagascar. Mauritius did so early July a few days after Didier Ratsiraka left for Paris, in France, together with his family.

Mauritian and Seychelles NGOs to collaborate on HIV/aids

Two non- governmental organisations, one from Mauritius and one from Seychelles, have announced their intention to set up a network of people infected with HIV/aids in the Indian Ocean.

"Talking about the disease helps to further the cause of HIV infected people. The objective is to eliminate bias ideas about the diseases", Reginald Hoareau, secretary of Faith & Hope (FAHA- Seychelles) and Nicolas Ritter, chairman of PILS(Mauritius).

Another project concerns the recording of compact-disc by artists from Mauritius, La Reunion and Seychelles, in order to collect funds to help HIV- infected people in this part of the world.

The POSB to become a commercial bank by 2003

The Postal Service is to undergo a major transformation in the structure, administration and the financial operations creating more employment for the Post Office Savings Bank (POSB).

The government are hoping that this change will allow the post office to become a public company. The new board, including the Chief Executive Manager Kris Lutchmeenaraidoo said that these measures are set to transform the postal service into a larger company under the name of Mauritius Post Ltd.

Krish Lutchmeenaraidoo said, " The idea is that the PSOB will eventually become a financial institution.'

Lutchmeenaraidoo had already had meetings about the eventual privatisation of the postal service. The major changes in Mauritius Post Ltd will be the effect of joining with POSB and changing its identity to a commercial bank of the island.

The changes will also include post boxes being compulsory, making collections in local areas easier. There will also be an introduction in the use of a post code, making delivery of letters a quick-

Lutchmeenaraidoo thinks that the new service of distribution will be more efficient. "With the introduction of the postal code, we hope to work collectively with the local people and the local authorities to create a uniform system." The introduction of postal boxes will also make collection easier. " It is important not to forget the person delivering and collecting the mail. The introduction of boxes will ensure that the system will be quicker and more efficient. Post boxes are functional and can be easily used for most letters and parcels in the local area".

The new project will also see the creation of a Postal authority, who will work closely with the Information and Communication Authority. The Postal Authority will be an organisation in control of all postal services and the quality of service. The board has placed emphasis on the modernisation of the existing infrastructure

The next big project will be the construction of the Postal Tower, proposed to be built at Ebene working with the Cybercity project. They are currently considering different designs by architects.







2000 census figures released

Population estimated at 1,117.100

The Population Census conducted by the Central Statistical Office in July 2000 reveals that the population of the Republic of Mauritius was estimated at 1,117,100 compared to 1,056,800 at the 1990 census. For the period 1999-2000 an average annual growth rate of 1.1 per cent has been recorded.

The 2000 Population Census enumerated 296,300 private households, representing an increase of 25 per cent over the 1990 census figure of 236,100. The household size dropped from 4.5 in 1990 to 3.9 in 2000 reflecting the continued tendency of newly formed families to make separate living arrangements. Furthermore, data collected during the census show that the population density increased to 578 persons per sq km from 518 persons at the 1990 census.

The sex ratio of the population is as follows: the number of males (men and boys) was 583,900 compared to 527,900 in 1990. The number of females (women and girls) was 595,200 in 2000 against 529,000 in 1990. Life expectancy at birth for men improved from 65.6 year in 1990 to 68.2 years in 2000 while for women the improvement was from 73.4 to 75.3 years.

The literacy rate of the population aged 12 years and above improved from 80.8 per cent in 1990 to 85.6 per cent in 2000. For males, the rate improved from 85.6 per cent to 88.7 per cent and for females from 76.1 per cent to 81.5 per cent. Moreover, the highest educational attainment of the population aged 15 years and above has improved between 1990

The proportion with primary school level only or below decreased from 59.4 per cent in 1990 to 49.8 per cent in 2000. During the same period, the proportion having passed School Certificate increased from 11.2 per cent to 13.6 per cent while the proportion having passed the Higher School Certificate increased from 3.4 per cent to 6.7 per cent. About 2.2 per cent had a tertiary qualification in 2000 compared to 1.6 per cent in

In the year 2000, the number of persons with a job was estimated at 466,300 compared to 407,600 in 1990, representing an increase of 58,700 which amounts to an increase of about 5,900. The employed male population was 310,800 while the females employed population was estimated at 155,000.

As regards the industrial sector of employment, the tertiary sector (trade, hotels and restaurants, transport and communication, financial services, community, social and personal services) accounted for 49 per cent of employment. The share of the primary sector (mainly agriculture) dropped to 12 per cent in 2000 from 17 per cent in 1990, while the percentage of the secondary sector (mainly manufacturing and construction) decreased from 43 to 39.

The number of unemployed unadjusted for possible overreporting, increased from 24,400 at 1990 census to 48,100 at the Census 2000. The corresponding unemployment rate works out at 5.6 per cent in 1990 and 9.6 per cent

Crab Soup

Crab soup is one of the first Chinese dishes to 'invade' the Mauritian kitchen. It is supposed to be an aphrodisiac and very good after a hangover. It started the fame of Gros Piti, a renown restaurant in Port Louis where the race-goers would eat in the evenings.

Ingredients

2 large live crabs

1 tablespoon of starch 6 red tomatoes

1 bunch of chopped thyme

Chopped onions **Preparation:** 4 big chopped peppers

1 pinch of red chilli or 2 fresh red chillies (according to taste)

1 teaspoon of ajinomoto 1 bunch of spring onions

Oil and Chicken stock

Kill the 2 crabs in the Chinese fashion, that is, by placing them into boiling water. Clean them and keep only the white parts and the claws. Throw

away the fat. Cooking:

Pour some oil into a Chinese wok, the onions and starch until brown, add the tomatoes and thyme. Cook for 4 minutes and add the crab meat. Stir until the meat becomes covered in the sauce.

Add the chillies, red pepper, crab claws and chicken stock, stew for 20 minutes on a low heat.

Before removing, add 1 spoonful of ajinomoto and chopped spring onions. The soup must be served very hot, ideally in Chinese bowls with Chinese spoons, which will keep the soup hot.

Commonwealth Games

Mauritian swimmer deserved a medal

In spite of their good performance during the several heats to reach the finals in various events, the Mauritian athletes stood no chance of taking a medal at the recent Commonwealth Games.

However, many including, News of the World Frank Warren who wrote in his column on August 4, believe that Commonwealth Games competitor Jaqueline Khadun from Mauritius should have received a gold medal if only for her courage and bravery.

Most people watching the games will remember Khadun, who received a 10 minute standing ovation inspite of her finishing 3 min 2sec behind most of the other disabled competitors.

Miss Khadun is 48 and suffers from polio and at one stage during the heat was seen holding on to the lane marker to catch her breath, which resulted in her being disqualified. However, it was not this which was still upsetting her one hour later, it was because she was three seconds outside her personal best.

Mauritius has lowest fertility rate in Africa

The US-based Population Reference Bureau published a report, in which it said Mauritius had a fertility rate of 2.0, the lowest in Africa compared to Nigeria (7.5), Somalia (7.3), Mali (7.0), Democratic Republic of Congo (7.0) and Uganda (6.9).

One official at the Health Ministry in Port-Louis said the report cites the lack of family planning as one of the threats to women's health in African countries.

The Minister said, that although women live longer than men, they face many unique health challenges, including the stress of childbearing.

According to the report, Mauritius had the highest rate of contraception in Africa and is the leader in family planning with 75 per cent of women making efforts to prevent contraception.

Meanwhile, a new report by the Central Statistics Office in Port-Louis estimated the population of the island at 1, 205 665 at December 2001 of whom 597, 207 were males and 608 458 females.

Concerning births, it said the number of live births recorded stood at 19, 667 in 2001, which represents a decrease of 2.7 per cent as compared to 2000 when the figures reached 20 205.

On the other hand, 7, 966 deaths were registered in 2001, causing a 0.2 per cent decrease, against 7,982 a year earlier.

The CSO also revealed that there was a 3 per cent decrease in the number of marriages in 2001 (10, 630) as against 10,963 in 2000.

I don't know what to do - I can't sleep or eat and I am becoming angry and ill with thoughts of jealousy and revenge.

Breaking up is always difficult but it is especially so when it is with a first girlfriend or boyfriend. It represents shattered dreams and hopes to the one who has not consented to the break-up. It is even more painful and heartbreaking to find out that another person is involved. The shock of discovering an unfaithful partner leads to anger, hurt, a violation of trust and usually dents one's self-confidence. Sometimes we wish to hurt the other party just so that they can experience our pain or suffering, or as a payback. Mixed emotions and confusion set in: there are many unanswered questions.

However, being jealous and holding long-term anger is unhealthy, as you have discovered. Whether you scheme, plot and take revenge subtly and behind the scenes or whether you take direct acts of revenge - it all leads to the same thing: you only really hurt yourself in the end. It is just not worth it.

Assuming your mutual friend knows his facts, just be grateful you found out what your ex is like; but also understand that it is tough being in a long-distance relationship. Not many people can cope with that situation over a long period of time. Also accept that people do change, including you. The situation shows the importance of communicating and meeting one another's needs and not assuming your partner is happy just because you are.

Once you can honestly assess your past relationship (with warts and all), the role you both played and the strain of circumstances, you may realise how lucky you are to be now free. There really are plenty more fish in the sea, especially when you are so young. Start afresh with all the joy and excitement of finding a new love and being "in love" again and learn from your past so that you have a better relationship.

Workshop seminar on the review of the National **Physical Development Plan**

The Government of Mauritius through the Ministry of Housing and Lands, has decided to update the 1994 National Physical Development Plan in the light of the rapidly changing events.

Because of the significant and long lasting adjustments to the economy and impacts to the environment, it now needs updating. Hon Moohesswur Choonee, the Minister of Housing and Lands opened the first workshop of the NPDP on the 18th July2002 at the Maritime Hotel in an endeavour to reveal the new strategically plan and vision to change the face of Mauritius in twenty years time.

These changing events and plans which need to be reviewed and be updated are as follows: The Government's aim to capture a bigger slice of the high-tech, IT and other knowledge-driven industries on purpose-built business parks.

Agriculture, Tourism, Manufacturing, Transport

The tourism industry's objective to maintain and enhance the image and quality of its products and in doing so develop coastal sites to major integrated resorts.

The agricultural sectors move to restructure the sugar sector, upgrade and diversify its activities and re-use some of it's land for development.

Manufacturing's challenge to remain competitive in textiles and other traditional markets whilst maintaining its existing operations, sites and workforce.

Transport pressures brought about by ever-increasing rate of car-ownership and worsening traffic congestion especially in the conurbation.

Constant changes to the environment in town centres, rural areas and on the coast, which threaten the image of the country and the livelihood of all its citizens and busi-

Consultation Process

The first Workshop is an important part of the consultation process which started in April 2002 and which will close in December when the revised draft NPDP will be completed. Such a consultation involves not only Central Government departments and agencies with an interest in Land Development, but also Local Governments, Private Sector, NGOs and Other Groups.

The aim is to involve as many as possible of these key stakeholders in the consultation, so that a consensus can be achieved on the key issues and development strategies which will be needed over the next 20 years.

Following the workshop, the current findings will be updated and a revised land development strategy will be prepared. The revised draft will then be discussed at a second workshop later this year when the main programmes of the strategy will be described.

Only after the second workshop, and when further modifications and refinements have been carried out, will the Development Plan be finalised.

In his address to the audience at Workshop. opening Mookesswur Choonee, the Minister of Housing and Lands gave an indication of the wish for the private sector to collaborate and participate in government projects, more precisely the tendency towards public private partnership (PPP).

Massive Investment

The Minister said that with the increasing cost of capital, he presumed that developments in future would rely heavily on the PPP mechanism. Mookesswur Choonee wants to maintain an enviable economic growth, massive investment in all sectors such as, transport, education, Information Technology and Health.

The Minister mentioned that 9 Sector Reports have been submitted and circulated for comments. These reports cover the following, Environment/Natural resources, Tourism, Economy, Land use, Settlement & Town Centres, Physical Infrastructure, Transport, and Agriculture.

The Minister of Housing & Lands also emphasised the need for good Town and Country Planning which is becoming ever increasingly important.

He said, "There are more pressures on our attractive and environmentally-sensitive coastlines and beaches with major private sector proposals for integrated resort developments, yet we need to maintain public access and enjoyment to these same national assets.

These bring along increasing pressures on infrastructure and services in our major towns and cities, with perhaps 50% more homes and jobs over 10-20 years, and with these will come a doubling in traffic flows, increases in congestion and decreases in the amount of open spaces."

According to Minister Choonee: "It is an important step forward in the consultation process which will help achieve a balanced development, taking into consideration future projects and lifestyle of the population. We can all help in identifying and refining these key issues and challenges so that the realistic and achievable development strategies can be put forward for future

Long-term Vision

He concluded on those terms: 'Our long term vision is for Mauritius to be an economically vibrant island. An island driven by cutting-edge technology, high value-added industries and services, quality tourism, a regional financial centre with good infrastructure and an appealing environment. An island where it will also be pleasant to live, work and enjoy life.The NPDP Strategy Study should capture the vision of Mauritius in the next twenty years."

Let us not forget that the NPDP Workshop wants to involve all of us to participate in this exercise and submit our comments and suggestions of how should we visualise the development of Mauritius in the next twenty years.

Tribulations of an ex-police Sergeant

Dany. B.., an ex-Police Sergeant is suing the Government of Mauritius for damages to the tune of Rs. 300,000 on the ground of having been forced to go on premature retirement at the age of 57 due to victimization.

As a matter of fact, in a report submitted in 1988 to the then Commissioner of Police, the late Mr Bhimsen Kowlessur, Dany had accused a senior officer of the Force of having misused "manpower" at the expense of the state. In fact, the said officer had detached a Police Attendant to serve at his official residence.

Dany declares that since then he had been subjected to several punitive transfers, and even demotion from Sergeant to Police Constable, in 1989, a few days before being confirmed in his post of Specialist Sergeant in the Police Internal Control Unit.

Although Dany was reinstated in his post of Sergeant in January 1992, he was nevertheless barred from sitting for the exams for promotion to the inspectorate, in December of the same year.

Furthermore, instead of being given the responsibilities and salary of a Police Sergeant, those of a specialised Police Internal Controller were assigned to him.

Dany avers that finally being unable to digest those injustices any longer, he bowed himself out of the police force.

Blind violence of a crazy old man

Following a Court Order, Veeren, a 32 years old father of two young children, has been evicted from his father's house. at Quatre Bornes in Plaines Wilhems district, since the 9

In a statement to the press, Veeren declared that, since his childhood, his mother now aged 56, his siblings and himself have always been the object of his father's violence, physical and moral torture.

He further stated that his younger brother, aged 26, had also been evicted by the old blind man some time back.

Veeren's wife and children have found provisional refuge at a relative's place in Mahebourg in the South-East of the island.

To cap it all, despite his blindness and his dependence on his wife for his personal needs, the old man has applied for divorce from his better-half since last year.

It is reported that the blind sexagenarian lapses into vulgarity whenever he is queried about his inhumane attitude towards his fam-

Mauritian wins Rs 75,000 in a anti-smoking competition

Mr Krishnaduth Bholah, a football coach from Quatre-Bornes has won a prize of Rs 75,000 in his effort to stop smoking. He won the African prize of the competition which had 388 participants.

Mr Bhola aged 40, a social smoker who smoked six to seven cigarettes a day said that it was not hard for him to give up. He was encouraged to enter the competition when his boss at the Municipality of Quatre-Bornes handed out entry forms to his employees.

Participants had to stop smoking

between 2 and 29 May, they then had to submit a sample for analysis. Mr Bhola who won a further Rs 25,000 on the Mauritian level, intends to spend part of his winnings on football equipment for the young football players from deprived families of Surinam. He will also contribute towards the cost of organising and flying over a group of footballers to La Réunion.



Child labour on the decrease in Mauritius

The number of children working in Mauritius is decreasing, from a total of 4,900 in 1990 to 1,600 in 2001, aged between 12 to 14 years old.

Most children end up on the child labour market after having failed at school. Most are employed by small businesses, restaurants, mechanics and in carpentry. Often exploited, many find themselves unable to turn down the work as they often contribute to the family budget. Some children find themselves working after school and return home too exhausted to do their school work.

The constitutional development of Rodrigues is moving forward with the adoption of Standing Orders for the Rodrigues Regional Assembly.

Members of the Assembly will benefit from duty free facilities for the purchase of cars and a Retiring Allowance provided they have completed two terms in the assembly and have contributed 4% of

their monthly salary into a pension

The Chief Commissioner for Rodrigues will earn a monthly salary of Rs 55,000 and members of the assembly will earn Rs 15,000

The number of people on the Rodriguan electoral list is 22,778. Election will be held September 29.

Blind people need help

According to latest figures available, 7,700 blind people in Mauritius are in need of financial help. Only a thousand of them receive some help from the Lois Lagesse Trust Fund

A report by the Social security and national solidarity ministry published recently said the Trust Fund would soon launch an awareness campaign to help these people. It said the outreach programme for the blind was not fully functional. «Outreach officers will guide and rehabilitate visuallyimpaired people island-wide until they can attend the Centre to join the school and integrate the training programme to avail themselves of the services offered», one Social security officer said.

New Deputy High Commissionner of India

Mr Dnyaneshwar Manohar Mulay is the new High Commissioner of India in Mauritius, succeeding Dr Atul Khare.


According to him, reforms announced in the education field give new responsibilities to the teachers as the number of subjects taught goes up, from five to six, apart from physical education, that is being introduced at primary




