Mauritius' Central Statistics Office forecast that 1 million tourists will visit Mauritius in 2013

according to their December's report, the Central Statistics Office expects that the number of tourists' arrival will reach 1 million in 2013. 965,000 visited Mauritius in 2012. It said tourist arrivals for the first nine months of 2012 increased by 0.2% to reach 675,584, compared to 674,383 in the corresponding period of 2011. Around 9% of the tourists came for holidays while 4.7% were on business/conference trips and another 2.6% were in transit.


The arrivals from Europe that accounts for 58% of total tourist arrivals decreased by 7.7% - from 421,060 in the first nine months of 2011 to 388,649 in the corresponding period of 2012. The arrivals from France, the leading European market, decreased by 11.9% to 179,328. The arrivals from other maior European markets. European markets major changed as follows: Germany (-2.4%), United Kingdom (-3.8%), Italy (-25.6%), Russia (+91.2%), Spain (+0.6%), Switzerland (+10.6%), Belgium

(-9.8%), (-7.4%), Austria Sweden (-11.5%) and (-18.9%). Netherlands Meanwhile, arrivals from Africa with a share of around 27% of total tourist arrivals rose by 13.2% to 184,485.

The arrivals from La Reunion increased by 19.2% to 96,567 and those from South Africa were up by 2.9% to 61,252. The following changes were registered from the other African countries: Kenya (+43.5%), Madagascar (+19.9%), Zimbabwe (+10%), (+43.5%) (+0.1%)Comoros and Seychelles (-16.4%).

The arrivals from Asia went up by 14.1% from 66,950 for up by 14.1% from 66,950 for the first nine months of 2011 to 76,378 for the same period of 2012. The following changes were noted: India ($\pm 0.7\%$), China (38.3%), Kong ($\pm 110.7\%$), United Arab Emirates ($\pm 44.6\%$), Japan ($\pm 13\%$), Malaysia ($\pm 1\%$) and Singapore ($\pm 15.2\%$).

Fatal accident in St. Julien: 12 dead and four seriously wounded

A fatal accident happened recently at St Julien, in the Eastern part of Mauritius. A mini-bus, carrying about 15 Bangladeshi workers on their way to work, and a HGV lorry transporting macadam collided. As a result of this collision, 12 people died on the spot with another dying in hospital two days later.

The dead bodies (11 Bangladeshis and the Mauritian mini-bus driver) are mostly employees from a nearby Textile Industry. All the Bangladeshi bodies were repatriated Bangladesh.

Four victims are still fighting for their lives in the Intensive Care Unit of the SSR Hospital.

Police are still making inquiries about the cause of this accident.

Former Lord Mayor found guilty of corruption

Tirat Moosun, the former Lord Mayor of the City of Port Louis, was found of corruption guilty (conflict of interest) by Intermediary Court of Mauritius. Moosun was accused of breaching article 13 (2) (93) of the Prevention of Corruption Act 2002.

Moosun supposedly gave favour to his sister, a Mrs Vimla Callychurn, by not adopting the proper legal procedure, as stipulated by law.

His sister obtained a market stall without even applying for it. At the time when his sister obtained this market stall, Moosun was the Lord Mayor of Port-Louis.

Moosun bypassed all applications made by other people and offered the market stall to his sister.

This matter only came to light when two market traders complained about it to ICAC (Ind Commission against Corruption) and police.

Reservoirs levels cause concern

The situation of Mauritius' reservoirs is still alarming. government has The decided to review the Water Rights Policy in Mauritius and all possible options to maintain a minimum water distribution have been considered.

Measures will be implemented to supply water to the different sectors of the economy throughout the year.

The Minister of Energy Public and Utilities announced his decision at a recent press conference. He expressed the

determination of the government to review the water rights policy in Mauritius. He has the backing of other Cabinet Ministers.

Comoros **President** visits Mauritius

The President of Comoros Islands, Ahmed Mohamed Sambi's first visit to Mauritius visit was focused primarily on the public health sector and the judiciary.

He was welcomed by the Minister for Foreign Affairs, Dr Arvin Boolell. The President was accompanied by his Minister of Health, Dr Sounhadj Attoumaned. On the Wednesday, he

made a courtesy call to Prime Minister Ramgoolam before meeting the leader of the opposition, Paul Berenger.

The delegation held a workshop at the Ministry of Health. Discussions centred on the updating of a partnership signed in 2001. agreement

Government purchases clinic

government has The bought The Med Point Clinic for the sum of RS 145 million. The Minister of Health and Quality of Life, Maya Hanoomanjee, admitted that the institution will be converted into a specialized centre for the elderly.

Located in Solferino, the Med Point Clinic closed down last September owing to financial problems. The clinic was formerly run by Dr Malhotra, the son-in-law of President of the Republic, Sir Anerood Jugnauth, and the brother-in-law of the Finance Minister, Pravin Jugnauth.

The Med Point Clinic sale led to questions from various quarters.

Officer attacked

Two armed men attacked a police officer when he was heading home from the harbour station on his motorbike.

The aggressors were also on motorbike. They overtook the police officer and then forced him to stop. They allegedly hit the officer on the head with their helmets. Then, one of them stole his motorbike. The police are searching for the two men.

Two hotel employees steal diamond ring

Two employees from the Sugar Beach Hotel stole a diamond ring, valued at 1,800 Euros (Rs 74,790), from a hotel room. The victim is a French tourist who was on holiday in Mauritius.

The accused were named as Vijay Ramesh, a 28 yearold room servant, and Archanand Bindyah, a 47 year-old bar attendant. Both men confessed to police that they did steal the diamond ring when arrested

The French tourist kept her diamond ring in the room of the Sugar Beach Hotel where she booked to stay whilst on holiday in Mauritius.

The tourist realised that her ring was missing from the place she kept it. She went to the police and complained.

Dead woman in boyfriend's house

A woman in her thirties was found dead in her new boyfriend's house at Pointeaux-Biches in the new year. Police suspect that she died of an alcohol overdose.

The woman left her exboyfriend in Triolet six months ago to go and live with her new one. The police are police investigating.

A 38 year-old woman in Baiedu-Tombeau was seriously injured when a car hit her recently and ran.

Car wash banned in Mauritius

Washing your car at a petrol station is now illegal. Anyone found wasting water either by having their car washed or using water for irrigation or cleaning purposes could be liable for a fine of up to Rs 200,000 and a maximum prison sentence of six months. This drastic measure by the

Central Water Authority (CWA) was taken because of the critically low level of water in the reservoirs and to mitigate water shortages.

Driving test fees up

Driving tests fees, as well as registration fees for taking the oral examinations component, have gone up. They are now Rs 300 and Rs 500 respectively.

According to a spokesman from the Driving Learner Institution, "practical tests to obtain a driving licence are done in three stages: firstly road driving, followed by reversing, and then parking"

Learner drivers must pay Rs 500 to do these three different tests each time. And if the learner driver fails, they must again pay Rs 500 to re-sit the exams.

The Lam Po Tang case

The atrocious murder case of Helene Lam Po Tang took a new dimension recently. A third suspect, year-old Kishan 33 **Dhooky** from Quatre Bornes, was arrested on in January.

Dooky was suspected of aiding and abetting. The new suspect is a close friend of Sanjeev Nunkoo, the alleged murderer who is in detention.

Gary Lam Po Tang, the victim's husband is accused of having ordered the murder of his wife.

Helene Lam Po Tang was stabbed 39 times and died in her house at Tombeau Bay last October

As from this month the Ministry of Civil Service and Administrative Reforms is putting in place a Customer Satisfaction Survey (CSS) which will help to measure the level of satisfaction the public gets from its various services provided by the Government.

The CSS would in the first instance target a limited number of public services and ultimately would widen the range to other Ministries/ Departments.

The survey will enable to identify performance gaps, determine where training is needed, what type of training should be provided and for whom, so as to address any shortcomings hindering service delivery in the civil service.

News Digest

Mauritius was signed recently by the Minister of Labour, Industrial Relations and Employment, Shakeel Mohamed and the International Labour Organization (ILO) assistant director general, regional director for Africa, Charles Dan.

The signing ceremony also included the signatures of the representatives of trade unions and the Mauritius Employment Federation.

The DWCP is based on three main priorities which are the creation of decent and productive employment with the provision of adequate social protection, strengthening of social dialogue and elimination of all forms of discrimination. The total cost of the programme is estimated at 2,080,658 USD.

Norwegian assistance for research in fisheries sector

A strategic partnership will be struck between the Ministry of Fisheries and the Norwegian authorities for more research activities in the fisheries sector within the next three years.

The goal is to improve production efficiency and environmental sustainability of the fisheries sector in the island. This will add to the

holistic type of education.

The new curriculum will be based on four key fields of study namely, communi-cation skills, numeric and problem solving skills, life skills and livelihood and trade skills. The new project will be phased in gradually as from the 2013 batch with transition arrangements for students already enrolled in prevocational education and be fully implemented by 2015.


Series of six programmes broadcast on Russian travel channel

No visits for SA prisoners in Mauritius From Paradise to "Island of tears"



An "island of tears"... that's how Patricia Gerber, whose son Johann is serving a nine years sentence for drug smuggling in Beau-Bassin prison, describes Mauritius. In November, Patricia and nine others families were denied the permission to visit their loved ones serving sentences, most of them for drug trafficking, in Beau- Bassin prison. The Mauritian authorities did not grant them the right of visit on ground of a late application for a group visit.

As things stand presently, most of the detainees do not - or rather, for financial reasons, cannot -receive visit of their relatives. Conditions of imprisonment, in terms of loneliness, food and communication also leave a lot to be desired. The psychological stress is without a doubt, unbearable for both the detainees and their families. The Locked up Organization strongly believe that the incarceration is the punishment and not the isolation from their family and loved ones

In 1996 Mr Mandela gave instructions to start negotiating Prisoner Transfer Agreements, which they were in the process of doing when Mr Mbeki was elected the new president. Jackie Selebi was appointed Director General of Foreign Affairs and when he got to hear about the negotiations, he immediately put a stop to it.

"My sister is HIV positive and we don't know if we will see her alive again"

Some South Africans are serving sentences up to 32 years, which in effect means they will NEVER see their families again.

Thandi Mbweu's sister was arrested for drug trafficking in 2007 in Mauritius and is now serving a 14 years sentence at the Beau-Bassin prison. Thandi said: "Since August 2007 we have never seen nor spoke to her. Since then, the only news I have got of my sister came from the department of foreign affairs telling me that she was critically ill. My sister is HIV positive, when I asked for her condition they were unable to answer me. She left her son in back home and he did not know if he will see her or speak to her again. "We don't have any money to go to Mauritius. We just want the

opportunity to see her alive as we don't know for how long she will live due to her condition."

Patricia Gerber is one of the voices of Locked Up organisation who fight for the rights of South African citizens locked up abroad. In 2007, Gerber's son was convicted and sentenced to nine years in prison for smuggling heroin into Mauritius in 2005. Patricia Gerber Patricia Gerber and her son Johann

claimed that "her son was targeted to be a drug decoy and in his naiveté agreed to take money to Mauritius in return for a free holiday. At the last moment he was threatened, and forced to take the drugs", Gerber said.

'We are not condoning what they have done but it does not help the South African Government boasting to have one of the best Constitutions in the world when they refuse to enter into a Prisoner Transfer Agreement with Mauritius. In fact it is stated 'In terms of Section 35(2) of the SA Constitution, every prisoner has the right to detention conditions that are consistent with human dignity, which includes the right to communicate with and be visited by spouses and children", Gerber said.

The punishment is the imprisonment not the isolation from families

Besides Ghana, South Africa is the only other country in the vorld that does not have a PTA with foreign countries. That means that the South Africans held in the Mauritian prisons are the only foreigners who are not allowed to return home to serve the emainder of their sentences close to their families.

The isolation these men and women, having no visits from family has a devastating impact on the lives of both the families and their loved ones. There is no reintegration back into society program for them when they come back, nor reintegration back into their families.

Most of the families do not have the financial means to go to Mauritius. "In the past few months we have seen a marked increase of families who do not even have the money to support their loved ones on a monthly basis due to the economic situation of our country", Patricia Gerber said.

"It's very hard being separated from Johann; we're a very close family. We have three other children and my husband, also named Johann, has struggled with losing their brother and son. My husband has taken it very badly he had a heart attack in September last year. He didn't have high blood pressure or cholesterol. He has a broken heart!

For seven years I have not given up. Letters, meetings and phone calls with Interpol, presidents, Amnesty International, ministers and government officials have brought nothing. Some days are very painful, if I didn't have God in my life I would have given up a long time ago!'

Denise Aimes: "My mother's wish is to hug her grandson before she passes away"

My nephew Edward Aimes has been in a Mauritian jail for 12 years and has never seen any of his family in that time. We send money to him and there is always a problem in him getting it. We are not a wealthy family but we try to collect money and send it to him some money and the occasional parcel. My mother, his gran, is 79 years-old and all she hopes and prays for is that she is still alive when he is released; also his Dad is not a healthy person. We try to keep constant contact with him to let him know that he still has the support and love of his family and we are here for him when has the support and love of his family and we are here for him when he comes home. I was given the opportunity earlier this year to go

and see him. This was a once in a lifetime opportunity for me as I would never have been able to afford to do that on my own, but when we were denied access to Mauritius. I was devastated. We spoke on the telephone and it was a very emotional conversation. Edward is starting to feel the pressure, being away from the family for so long and is quite depressed. I last sent money to Edward at the beginning of November and as I am writing this it is the 27th of November and he still has not received it. Why can't our children come home to fulfil their sentence and be near the family We miss him so much. Please bring him home!

Australian-born Mauritian attacked policeman in front of Parliament before committing suicide with the officer's gun



According to the Melbourne Homicide Squad, the attacker, David Hollingsworth, 30, of Chadstone, is of Mauritian background. The latter grabbed the victim's gun after attacking him with a hammer in front of the Australian Parliament on December 10.

After stealing the gun, David Hollingsworth ran towards the Melbourne Cricket Ground where he shot himself minutes after the attack in front of the Parliament.

The policeman who remains in Royal Melbourne Hospital, had worked in factories before becoming a PSO seven years ago. He is father of two children, aged 29 and 19. He had undergone surgery after skull fracture caused by the hammer blow.

The Australian press reported that Mr Hollingsworth's mother called Lifeline in the days before the incident in a desperate effort to get him help. According to police, Hollingsworth was known to their services and had mental health issues.

The Chagos Archipelago legally belongs to Mauritius

The issue regarding the Chagos archipelagos remains very controversial. Aside from the dilemma of forceful deportation of its inhabitants lies the dispute over the sovereignty of the group of islands between the Mauritius and the UK. The UK, treating the islands as its own, has leased the largest islands of the archipelagos,



Diego Garcia, to the USA for military purposes. However, under international law, it appears that sovereignty over the Chagos

islands belongs to Mauritius. Historically, Mauritius and the Chagos islands belonged to France. Following the capture of Mauritius by the British in 1810, France relinquished Mauritius and its entire dependencies, including the Chagos

relinquished Mauritius and its entire dependencies, including the Chagos islands, to Britain. A legal document was drafted to that effect, namely the Treaty of Paris 1814, which is the starting point for the argument that the Chagos islands form part of the Mauritian territory. In the beginning of the sixties, the USA became interested in the Chagos islands, Diego Garcia in particular, in order to set up its military base in the region and approached UK for a potential lease of the islands. However, at the same time, Mauritius had started negotiating its independence from the UK, which effectively meant that UK would cede sovereignty over the islands. Since USA would rather trust UK rather than a future Mauritian government, USA and UK conspired to detach the Chagos islands from the Mauritian territory before granting Mauritius its independence in 1968. In 1965 the UK government, by way of an Order in independence in 1968. In 1965 the UK government, by way of an Order in Council, enacted the 'British Indian Ocean Territory Order (S.I 1965, No 1920)' which sought to render the Chagos islands a separate colony from Mauritius and to be named as the 'British Indian Ocean Territory' (BIOT).

Nonetheless, although at that time UK had sovereignty over both Mauritius and the Chagos islands, it is suggested that the British Indian Ocean Territory Order was unlawful under international law. In 1960, five years before the enactment of the Order in Council, the UN General Assembly passed the Resolution 1514, which makes it unlawful and contrary to the UN Charter for any decolonising state to disrupt the territorial integrity of any of its colonies (paragraph 6). The Resolution makes it clear that UK's attempt to sever the colonies was unlawful and that the British Indian Ocean Territory Order was contrary to international law. Therefore, Mauritius should possess the same territory and boundaries that it enjoyed before its independence.

Furthermore, the fifty-year lease of the Chagos islands to the US effectively violates the right of the Chagossian nation to be an independent state, which is known under international law as the 'right to selfdetermination'. Such a right is recognised and codified under the same UN General Assembly Resolution 1514.

The possible defence argument for the UK might be that Mauritius did consent to the excision of the Chagos archipelagos from its territory. However, this argument does not seem to hold water. According to Paragraph 5 of the Resolution 1514, UK had the duty to transfer all the powers regarding Mauritian territories to the Mauritian people without any conditions or reservations. Thus it is clear that upon the negotiation towards the independence of Mauritius, any condition or deal imposed by the British on Mauritius about the surrender of the Chagos islands in exchange of granting independence, was also illegal. In any event, at the time of the negotiations Mauritius was not yet an independent state. Therefore, any negotiation about the excision of its territory could not have been made to a legitimate and competent Mauritian government who had the legal power to consent to a matter of such an importance.

Yet, the difficulty lies in affirming the Mauritian sovereignty in the International Court of Justice (ICJ). The reality is that Mauritius cannot seek redress in the ICJ because UK had included a very crafty provision in its declaration of acceptance of the ICJ's jurisdiction. The effect of that provision effectively prevents any Commonwealth country from suing the UK in that court. Following threats of the Mauritian prime minister, in 2004, to withdraw from the Commonwealth in order to sue UK, the provision was hastily amended to include previous Commonwealth countries as well. Therefore, it would hardly matter even if Mauritius leaves the Commonwealth.

Geoffrey Robertson QC, a distinguished member of the UN's Internal Justice Council suggests that Mauritius should request an advisory opinion from the ICJ on the issue of sovereignty over the Chagos islands. Although advisory opinions are non-binding in nature, it does not mean that they lack legal power. In fact, they are highly regarded in international law as they are assertions made by the ICJ on international legal obligations. They also carry significant moral authority and contribute in interstate diplomatic negotiations. Hence, the more accurate question is not whether UK will comply with the Advisory Opinion, but rather whether it will comply with its legal obligations under international law. It is hoped that UK would avoid being branded a rogue state in the international arena and may consequently honour its obligations.

Somuth Soborun, Mauritian Ampassador to the United States fined for underpaying staff

Somuth Soborun pleaded guilty to the charge of nisdemeanour for failing to pay a domestic worker the minimum ourly and overtime wages between December 2008 and August 009. He was ordered by the US Magistrate Judge Patty Shwartz p pay a fine of more than 5 000 US dollars.

According to the prosecution case, Soborun "took advantage of he employee, who had no opportunity to socialise and worked for 2 hours a day, six days per week. Counsel for the defence stated in his plea that his client

nderstands "that what he did was wrong and has learned a aluable lesson." To add that the "shame and embarrassment" was nough as punishment. "Like all human beings, I have failed", aid the ambassador. The latter has already paid more than 0,000 dollars to the domestic worker as restitution.

Municipal Elections 2012 The purple wave hits th<u>e towns</u> Curepipe



The recently concluded municipal elections in the municipal elections despite their defeat. There is highlight several points about the current trend of Mauritian politics and further fuel the debate about the actual strength of the Government. The alliance Mauritius Socialist Movement (MSM) and the Mauritian Militant Movement (MMM) won 53 seats, the Government coalition which comprises of the Labour Party (PTr) and the Mauritius Social Democrat Party (PMSD): 36 seats and the Mauritius Social Democrat Movement (MMSD) one seat. In a snapshot, the overall results show that opposition alliance is the great winner of this political joust. But are they really the winners? Was this a "political tsunami" as forecast by Sir Aneerood Jugnauth ex-President of the Republic and leader of the MSM-MMM alliance aka **Remake 2000?**

The Prime Minister believes that the results show a "decline" in the influence of the MMM in urban areas and affirms that most of the population has faith in his Government. Ramgoolam stated to the press that he was satisfied with the issue of this joust. However, it's obvious that his speech would have been different if his coalition had won this urban challenge. On the other hand, Paul Berenger in his speech in front of the Port Louis Municipality after the proclamation of the results said that "the remake 2000" has become stronger and that they were ready for the parliamentary election (in 2015).

"If you have a look at the results, you'll see that there has not been a tsunami as predicted by the opposition" said Ramgoolam who also stated that he would contest the results of some councillors.

It's the start of a new drama and the main actors will be Paul Berenger, The Jugnauths (father and son), Xavier-Luc Duval and Navin Ramgoolam. The script has not yet been written but we have clear indications that the political landscape will encounter drastic changes in the near future, as it always happens after the proclamation of elections' results. Who will renegotiate? Will the remake 2000 split again? The answers will come

sooner than we think.

The race to 2015 is still open. None can say who will win the next parliamentary election. Will the country put their trust in the Remake 2000 (version 2015) with Sir Aneerood Jugnauth as Prime Minister at the age of 85, for a three-year term? No one knows. But everyone knows the reason of his comeback into the political arena. He stepped in, once again, to save his son who lacks credibility as a political leader. He lacks the charisma and leadership to hold the reigns of the MSM in the jungle of the Mauritian politics. He is like a small "nemo" swimming in a pond of sharks. He is also a nemo in the latin meaning of the word.

Furthermore, we must not write off the possibility of an alliance between the MMM and the PTr "for the sake of the country." The two parties are the best enemies in the world. They hate each others in the limelight but kiss in the dark. Winning the towns has increase the bargaining power of Berenger; the purple wave can easily reach the shores of the Labour Party. Months ago, the Best Loser negotiations gave the two leaders an excuse, in the eyes of the public, to talk, but everybody knows that the BLS was not the only topic on the agenda. This time the next "talk talk" meeting will be the political reforms, let's wait and see.

In 2010 the MSM was in love with the PTr-PMSD leaving the MMM all alone in the opposition. In 2015 maybe the role will swap.

Berenger as Prime minister and Ramgoolam as President with powers in the Second Republic of Mauritius. Let's wait and watch this drama... The actors are getting ready to surprise us. Will Duval accept Guimbeau as an ally, when the latter is a threat to his party in his beloved Curepipe? Will the MMSD of Guimbeau surprise again? Answers soon ...





The archipel of **Chagos revisited**

Bicentennial Memorial Tribute to Harriet Atwood Newell

On the initiative of Professor Vinesh Hookoomsing, formerly Pro-Vice Chancellor of the University of Mauritius, a memorial tribute was paid to Harriet Atwood Newell, a Christian missionary lady who died in Mauritius (former Isle de France) on 30 November 1812. The ceremony which was held near the tombstone of the lady at the Western Cemetery at Les Salines, Port Louis, was attended by Troy Fitrell, Deputy Chief of Mission of the American embassy, and Marc Etive, Executive Director of the Bible Society of Mauritius. It is during the international conference held for the bicentenary of the Bible Society of Mauritius at Institut Cardinal Jean Margéot on November 9 that Professor Vinesh Hookoomsing first made a public reference to the lady missionary and her untimely death at the age of 19.

At the start of the bicentennial ceremony Professor Hookoomsing presented an address based on various sources he had consulted about the tragic fate of lady Harriet Atwood Newell whom he considered to have been a "Martyr of the British Empire" in India. As a matter of fact, the lady missionary and her husband Reverend Samuel Newell as well as another missionary couple Reverend Adoniram Judson and his wife Nancy, were not allowed by the British colonial authorities to do missionary work in India (the more so as Britain and USA were at war in 1812) and were asked to leave the country. They retreated to Mauritius (Isle de France) where Harriet met her tragic fate and lost her new-born daughter on the way at sea

Professor Hookoomsing referred to a passage of the book "Sub-tropical Rambles in the Land of the written by Nicholas Pike, Aphanapteryx" American Consul stationed in Mauritius in the 1870's, in which he described the burial-ground as a place where "the very air oppresses" and "the absence of tall trees and shade, and the bright glare of a tropical sun, destroy the feeling of rest that such a place should give." The American Consul painstakingly reproduced in his book the inscription on the tombstone:

Sacred to the memory of Mrs. H. Atwood, Sacred to the memory of Mrs. H. Atwood, Wife of the Revd. S. Newell, Missionary at Bombay. Born at Haverhill, Mass. U.S. America Oct. 10, 1793; Died after a distressing voyage From India to this place, Nov. 30, 1812. Long devoted to Christ, her heart burned for the beathen heathen. For them she left her kindred and her native land, And welcomed dangers and sufferings. Of excellent understanding, rich in accomplishments And virtuous. The delight of her friends. A crown to her husband, and an ornament to the missionary cause. Her short life was bright, her death full of glory. The Executive Director of the Bible Society of Mauritius observed that the arrival of the Newells in Mauritius coincided with the setting up of a branch of the British and Foreign Bible Society under the name of « The Bible Society of the Islands of Mauritius, Bourbon and Dependencies ». As a matter of fact, this bible society in Mauritius was launched on 11 November 1812 with the blessing of the then British Governor Sir Robert Townsend Farquhar, sealing the adamant efforts deployed by the Civil Chaplain Reverend Henry Shepherd to that end. So, when the tragedy hit the Newells a Bible Society had already started operating on the island with jurisdiction on its dependencies and the sister island of Bourbon. Reverend Samuel Newell stayed on the island three months after his wife's demise. Was he apprised of the existence of a Bible Society in Mauritius? If so, he must have felt, as a Christian missionary, some sense of satisfaction, carrying away with him the assurance that there exists in that foreign island a structure to ensure the propagation of the Holy Bible.

The Deputy Chief of Mission Troy Fitrell expressed his gratefulness to the Mauritian party for organizing this memorial tribute in remembrance of "*a countrywoman of my own*" (a quote from the American Consul Nicholas Pike) and marvelled upon learning that diplomatic and trade relations between Mauritius and the USA are more than two centuries old. He was thankful for the two funeral wreaths laid on the tombstone to conclude the memorial tribute to Harriet Atwood Newell who three weeks before reaching Mauritius had given birth to a baby girl at sea. The baby who was given the same name as the mother, survived only for five days. She breathed her last on the bosom of her mother and was buried at sea



Mention of Harriet's grave has been made in the 1870's by the then American Consul posted in Mauritius, Nicholas Pike. "I was surprised once, when reading over the names, to come upon one of a countrywoman of my own - a name well known in America, and for those to whom she is still a household name."(2)

The Consul took trouble to copy the inscription on the tombstone and reproduce it in his book. The tombstone has been given a fresh coat of paint and the inscription brought out in view of a bicentennial memorial tribute paid to the missionary lady on 30 November last.

About a year later after the demise of Harriet Atwood Newell, her husband, Reverend Samuel Newell, evoked the tragedy in a moving letter addressed to his mother-in-law, Mrs. Atwood. An extract of the letter, written at Point de Galle in the island of Ceylon, reads thus:

"My dear, dear mother, It seems too much to believe that this paper will ever reach Haverhill, and be read in that peaceful dwelling, where I have spent so many hours. But your letters have safely reached me, and gladdened my sorrowful, desponding heart, in this distant region; and why should not mine be safely conveyed to my beloved mother? I hope this will reach you, and remind you of one - on whom you have bestowed the greatest blessing which any person on earth could bestow. That blessing, alas, how transient! - It was resumed by that sovereign God, from whom is every good gift, and I am left to mourn. – Yes, my dear mother, within ten short months from the day you gave your Harriet to me, I saw her sicken, waste away, and expire. In a strange land, without one friend to weep with me, I followed her, a solitary mourner, to the grave. She was interred in a retired spot, in the burying ground in Port Louis, under the shade of an evergreen. I often visited the spot with mournful satisfaction, during the



However, the initial plan was that the two missionary couples, the Newells and the Judsons, would embark together for Mauritius. But circumstances were such that they travelled separately to Isle de France, the Newells first and the Judsons later. "They then asked if they could go to the Isle of France (Mauritius). This request was granted; but the only ship then setting sail for that port could convey but two passengers, and by common consent Mr. and Mrs. Newell embarked. Mr. and Mrs. Judson and Mr. Rice remained behind for another vessel."(8)

After some two months and quite a few administrative obstacles set by the British authorities, the Judsons and Rice managed to get a passport to sail to Isle de France on board "La Belle Créole". "After a voyage of six weeks they arrived in Port Louis, on the Isle of France, January 17, 1813."(Ibid)

Tragedy at sea and tragedy on land for the Newells

The Newells made their journey Mauritius without the Judsons. So when tragedy would strike the couple twice, once at sea and another time on land, the Newells would indeed be all alone to shoulder their pain and mourn in silence. First, both husband and wife mourned the untimely death of a new-born.

"Three weeks before reaching the island she became the mother of a child, which died in five days."(1) This was indeed a trying time for the Christian missionary couple - to see their dear baby dying away.

Isle de France had just been taken by the British which named it Mauritius (1810) and was ruled by a British governor, Sir Robert Townsend Farquhar. So, after "four months in Mauritus, largely spent in mission work with English soldiers"(8) and not with the masses, they embarked on the 'Countess of Harcourt" on 7 May for Madras, India, whence, on June 22, they would proceed to Burma, the country they had initially planned to evangelize.

In the meantime, on February 24th, Mr. Newell embarked for Ceylon, and on the 15th of March, Mr. Rice proceeded to the United States to campaign for the setting up a Baptist Missionary Society to support the work of Baptist missionaries as Adoniram and Nancy Judson abroad. T

he latter would visit Mauritius from Burma on two occasions in 1841, on account of ill-health of their children, and in 1845, 'as his health and his wife's was so broken". (Ibid)





people wear Acanthamoeba Millions contact lenses all over the diagnosis is usually reached wold as it is very practical. The introduction of disposable daily lenses has encouraged more and more people to opt for contact lenses rather than glasses.

However not many wearers of contact lenses have seriously thought of the risks involved in using contact lenses. Recent warnings from scientists in the United Kingdom have drawn our attention to something that a lot of contact lenses wearers do without realising that this could result in blindness

Washing contact lenses in tap water

Contact lenses should never be washed with tap water as there the risk of catching Acanthamoeba. Acanthamoeba is a naturally occurring singlecelled organism that is found in untreated soil and liquids including tap water. If it gets into the lens and comes in contact with the eye, it can penetrate the cornea and cause Acanthamoeba keratitis. As a result great damage can occur to the eyes. Symptoms include redness and eye pain, tearing, light sensitivity, blurred vision, discharge and feeling as though there is a foreign body in the eye. As many of the symptoms resemble those associated with Pinkeye, Acanthamoeba keratitis can be difficult for an eye doctor diagnose.

keratitis when the symptoms persist despite antibiotics. The presence of a ring-like ulceration in the eye can also be used as an indicator. While Acanthamoeba poses a risk to everyone, contact lens wearers are at particular risk. Statistics from the UK show that around 75 people have to deal with serious caused damage by Acanthamoeba per year.

Dr Fiona Henriquez from the University of the West of Scotland who has been conducting tests on new lens solutions fight to Acanthamoeba contamination said:

"It is a potential problem for every single contact lens wearer. The incidence is quite low but that may be a problem with diagnosis. There are no effective drug treatments. The drugs used are often ineffective. It requires hospitalisation and applications of a toxic substance to the eye. "We're trying to improve the

elimination of this parasite and prevent blindness. If treatment isn't effective, there is the possibility of blindness and the need for a corneal transplant. An estimated 3.7 contact lens wearers in the UK and more than 125 million worldwide are at risk from acanthamoeba"

Though this news is very disturbing, it is encouraging to know that some things can be

done as a means of prevention. There are a few simple things you can do to reduce the risk of infection.

Taking extra care by following the following steps

Follow instructions on how to care for your lenses that were given you by your eye doctor. * Use only products that your

eye doctor recommends. Never use tap water to clean

contact lenses. * Never swim, shower or use a hot tub while wearing them. If you must wear your contact lenses while swimming, make sure to wear airtight goggles and afterwards dispose of your lenses

* Single use daily contact lenses are considered safer than reusable ones.

If your lenses are not disposables, upon removing clean them always multipurpose solution and then store them overnight in fresh disinfecting solution.

Make sure to replace your lenses as often as is recommended by your eye doctor.

Lastly always wash and thoroughly dry your hands before handling your lenses.
